ITEM 1 CONFIRMATION OF MINUTES OF THE PREVIOUS MEETING

ITEM 4 NEW PROPOSALS FOR STANDARDIZATION

4.1 A New Work Item Proposal has been received by the Veterinary Hospital Planning Sectional Committee. Refer **ANNEX C**.

Committee may kindly deliberate.

4.2 The committee may deliberate on the emerging fields in the area under its scope and decide formulation of Indian Standards on the same. The committee may define thrust area which should take into consideration the standards development required in the given context keeping in view the social, environmental and economic consideration.

4.3 As per guidelines received from Competent Authority of the Bureau, any new proposal for standardization should essentially be made on the prescribed proforma as a preliminary work item.

4.4 It may further be added that the proposal received at **4.2** has to be analyzed by the member secretary in the prescribed proforma enclosed at **ANNEX D** for consideration of the technical committee/ screening committee keeping the following in view:

- i) What is the feasibility of achieving consensus on national standards in this subject area by the proposed target date;
- ii) How many members besides the proposer agree to the proposal and how many are ready to actively participate in the development of project;
- iii) Whether any outside funding is possible;
- iv) Only those subjects should be taken up which have a potential to mature into a standard in the stipulated time.

ITEM 5 BIS-CONNECT

BIS has developed a software 'BIS-Connect' to efficiently handle the works of standards formulation activity. The upgradation of this software is an ongoing process, taking care of the needs expressed by the stakeholders from time to time.
