ITEM 0. General

ITEM 0.1 Welcome Address by the Member Secretary

Sh. Chandan Kumar, Member Secretary extended a warm welcome to the Chairperson, Vice-Chairperson and all the members present in the 21st Meeting of Health Informatics Sectional Committee, MHD 17. He conveyed his gratitude to all the participants for sparing their valuable time to join the meeting.

He delivered a presentation providing an overview of the standardization initiatives undertaken by BIS in the realm of Digital Health/Health Informatics through the MHD 17 Committee. The presentation has been distributed to all committee members.

ITEM 0.2 Opening Remarks by the Vice-Chairperson

Dr. Ashok Kumar, Chairperson of MHD-17, extended a warm welcome to the Vice-Chairperson and all members at the 21st meeting of the MHD-17 Sectional Committee. He conveyed his delight at the substantial attendance of members in the meeting, which represented a diverse group of stakeholders. He also conveyed his happiness that the meeting coincided with the eve of World Standards Day. He commended the members for their active and significant contributions over the years, specifically acknowledging their efforts in formulating over a hundred Indian standards in the field of Health Informatics.



Item 1 Formal Confirmation of Minutes of the Previous Meeting

1.1 The Committee approved the minutes of previous (Twentieth) meeting circulated vide BIS DG letter No. MHD 17/A-2.19 dated 08 September 2023 without any change.

ITEM 2 BIS Guidelines for Research & Development Projects for Formulation and Review of Standards

The Committee noted the BIS Guidelines for Research & Development Projects for Formulation and Review of Standards and members were encouraged to propose R&D projects for formulation and review of standards as per the scope of MHD 17 in line with the guidelines.

ITEM 3. Draft Indian Standards for Finalization

The Committee deliberated on the Draft Indian Standards which had completed the wide circulation stage and as no comments were received on these documents during the WC period, it was decided to finalize the following documents for publication:

ITEM 4. Draft Indian Standards for Approval for Wide Circulation

4.1 It was decided to circulate the list of standards published by ISO/TC 215 and SC 1 along with their status of adoption among the members requesting them to identify and share the standards that should be adopted as Indian Standards.

ITEM 5. New Subjects

5.1 The Committee was informed that any new proposals for standardization can be submitted online on the BIS website www.bis.gov.in.

A presentation on 'Clinical Evaluation of Digital Therapeutics' was made by Dr. N. K. Singh, Digital Health Associates Private Limited, New Delhi. The Committee appreciated the relevance of the subject and suggested to get the relevant details of the ongoing work related to Digital Therapeutics in ISO/TC 215 before proceeding further. It was decided to nominate Dr. Singh as an expert on WG 11 'Personalized Digital Health' of ISO/TC 215.

ITEM 6. Review of Subcommittees/Panels under MHD 17

6.1 Health Informatics – AYUSH Subcommittee [MHD 17:1]

The Committee was briefed about the status of the ongoing projects ISO/TS 6204 (Categorial structures for representation of Ayurvedic medicinal water — Decocting process) and the proposed New Work Item Proposal (NWIP) on Information Model of Prakriti. It was informed that the comments received on ISO/TS 6204 during the CD Ballot stage have been resolved and the



resolution of comments has been shared with the Secretariat. The submission of Form-04 and working draft for NWIP on Information Model of Prakriti will be deliberated in the next Subcommittee meeting. The Committee also noted the progress on the project started under WG 6 'Pharmacy and Medicine Business' to document gaps and/or challenges with ISO 11239 (Data elements and structures for the unique identification and exchange of regulated information on pharmaceutical dose forms, units of presentation, routes of administration and packaging) in the context of traditional medicine.

6.2 Telehealth Subcommittee [MHD 17:2]

Mr. Gaur Sunder, CDAC, Pune (Convener, MHD 17:2) informed the Committee that the CDAC team has prepared the Table of Contents (ToC) document which will serve as the structure of the proposed standard. This document has been shared among all the members of the Subcommittee for their feedback/comments and a meeting will be called soon to deliberate on the ToC and drafting process.

6.3 Disability Informatics Subcommittee [MHD 17:3]

Prof. R. Rangasayee, Convener of MHD 17:3, informed the Committee that Ms. Manisha Mantri has joined the MHD 17:3 Subcommittee as a representative of NRCeS, CDAC, Pune. In the Subcommittee's 4th Meeting on October 10, 2023, Ms. Mantri emphasized the necessity to bifurcate the existing work into two segments: Disability Informatics-Format for Disability Data Exchange and a separate standard for Disability Survey and Reporting. The Subcommittee has resolved to conduct its next meeting in Bengaluru on November 29th and 30th, 2023, with a face-to-face interaction.

6.4 Cybersecurity of Network-connected medical devices – Panel [MHD 17:P2]

Convener Sh. Rajendra Prasad (Vice-Chairperson, MHD 17) was requested to reconstitute the panel and finalize its scope and ToR.

6.5 Medical Icons – Panel [MHD 17:P1]

On the recommendation of Dr. S B Gogia, Convenor, MHD 17:P1, it was decided to reconstitute the Panel and the new composition is as follows:

Dr. Gogia briefed the Committee about the status of ISO/CD TR 6231 'Health Informatics – Standardizing Graphical Content' which has completed CD stage and the resolution of comments received on the CD ballot will be discussed in the Arlington meetings (8-16 Nov 2023) of ISO/TC



215/WG 3 'Semantic Content'. He also briefed the Committee about the two new work items which will be proposed by him to WG3, one dealing with guidelines for icons and graphics creation and other one linking icons and graphics with terminologies.

ITEM 7. International Organization for Standardization (ISO)

7.1 The Committee noted the information about the scope of ISO/TC 215 'Health Informatics' and ISO/TC 215/SC 1 'Genomics Informatics' as mentioned in *Item 7.1 of the Agenda*.

The Committee noted the information regarding the P-membership of BIS(India) on ISO/TC 215 and ISO/TC 215/SC 1 which makes it mandatory for us to vote on all draft standards and other documents circulated by TC 215 Secretariat seeking votes/comments.

In order to strengthen India's participation in ISO/TC 215 activities, the Committee decided to nominate the following experts on the Working Groups of ISO/TC 215 as given below:

7.2 The Committee noted the Indian delegation scheduled to participate in the Plenary and Working Group meetings of ISO/TC 215 and SC 1 from 8-16 Nov in Arlington, VA, USA. The Chairperson emphasized the significance of the delegation's successful engagement in these meetings and recommended that the Head of Delegation conduct a comprehensive review of all presentations in advance to ensure uniformity, coordination, and understanding among the delegates. The Committee was apprised of a planned briefing meeting for this purpose, facilitating a thorough review of all presentations and the finalization of India's stance on agenda topics.

7.3 Hosting ISO/TC 215 Plenary and WG Meeting in India in 2024: Considering the schedule of IEC GM 2024 during 21-25 Oct 2024 in Edingurgh, UK, the Committee recommended to postpone the meeting and reschedule it in consultation with ISO/TC 215 Secretariat/leadership.
