ITEM 0 WELCOME AND OPENING REMARKS

Member Secretary extended his greetings to all the members present in the meeting. The meeting commenced with the introduction of the members.

ITEM 0.1 WELCOME ADDRESS BY HEAD (MHD)

Head (MHD), Shri A. R. Unnikrishnan, warmly welcomed all the members present in the meeting and requested their active participation in the technical deliberations.

He cited a few examples of pet animals being exposed to trauma while undergoing diagnostic examinations like X-ray due to the poor infrastructure and facilities available at the Veterinary clinics and hospitals. He suggested that committee shall take into account the standardization being carried out in the pet friendly countries like France and Germany. He also requested the committee to identify and develop more Indian Standards for Veterinary Medical Devices in par with the international practices.

He also congratulated and extended best wishes to Dr. (Prof.) K. M. L. Pathak on his appointment as the new Chairperson of the Veterinary Hospital Planning and Surgical Instruments Sectional Committee.

ITEM 0.2 OPENING REMARKS BY CHAIRMAN

Dr. K. M. L. Pathak, welcomed all the present members.

He agreed with the opening remarks of Shri A. R. Unnikrishnan, to develop Indian Standards on Medical Devices and Surgical Instruments for the pets and large animals equally. He emphasized on the important role the livestock play in the sustaining the livelihood of huge number of Indian population and expressed a need to develop relevant Indian Standards to safeguard their needs. He requested support from all the veterinary experts in the said endeavor.

The Committee requested Dr. A Arun Prasad, Tamil Nadu Veterinary and Animal Sciences University, to provide a working draft on revision of **IS 14420 : 1996** 'Tracheal Tubes For Large Animals Used for Veterinary Anaesthesia – Specification' incorporating his comments.

The working draft will be shared within the committee as P-draft for perusal and comments for a period of 30 days.
