To formulate Indian Standards for instruments used in ear, nose and throat surgery including ENT microsurgery instruments, ENT implants, vibrators, audiometers, hearing-aids tuning forks, hooks and elevators, diagnostic instrument, etc.

  - a) Consumer interests shall, as far as possible, predominate. In case, non-industry interests are less than two third, it may be reviewed to ensure that 2/3rd of the total representation on the committee is from non-industry.
  - b) Only relevant organizations/government departments/consumer organizations and regulatory bodies that are related to the subject may be offered representation.
  - c) Non-active members to be withdrawn
  - d) Young professionals who can contribute in the working of the committee may be coopted. The committee may deliberate on the same and advice.
