Item 3 RESEARCH PROJECT UNDER SSD 14

The Director General of BIS conducted a workshop on Research and Development in standardization on 30 June 2023. During the workshop, the DG, BIS has directed to conduct research on important subjects taken for standardization under various technical committees of BIS to know the

processes, best practices and methodology adopted that can be incorporated in the draft Indian Standard.

In the workshop, the Services Sector Department proposed R&D project on water audit and water use efficiency to the DG, BIS. As per BIS guidelines (attached at Annex A), the research project can be taken up by any member organization of the Drinking Water Supply, Wastewater and Stormwater Systems and Services Sectional Committee, SSD 14 having expertise on the subject matter.
