This has reference to the development of PP and Jute Blended bags known as "Smaart Jute" Bag for packing of food grains like paddy, rice and wheat etc.

We introduce ourselves as one of the leading manufacturers of Polypropylene Woven Sacks in India and with an experience of over 38 years.

Recently, we have started manufacturing Jute/PP union bags in 75:25 ratio conforming to JPMA 1987. The "Smaart Jute" bags have been manufactured as per draft BIS standard IS:21242 with 94 cm +/- 6 cm & Length is 57 cm width with average weight of 360 grams with acceptable tolerances.

The bags developed are strong, light weight and recyclable. We have the capacity of more than 500 circular looms which can manufacture these bags in bulk quantity. The bags manufactured will be cheaper compared to traditional Jute bags.

We understand that BIS specification of Jute-PP union bag is in the final stage of development. Here we would like to convey that the Single Ply Jute yarn 13/14 LBs used for the manufacture of Jute/ PP bags has been procured from Indian Manufacturer only. Similarly, PP yarn has also been procured from Indian sources only.

The above facts are being provided to ensure that Jute/PP Union bags are being manufactured from Indian made raw materials like Jute yarn and PP.

We are enclosing herewith the invoice copy of procured Jute Yarn from Indian Manufacturer. We are also enclosing certificates from various Indian Jute Yarn Manufacturers for your kind perusal.
