ITEM 10 INTERNATIONAL ACTIVITIES:

The committee noted that currently there are no international activities related to standardization in Siddha, this item is not applicable to AYD-05. However, it was requested to share details of foreign delegates who are working in the field of Siddha as well as Siddha Physicians practicing in foreign countries so that a dialogue can be initiated regarding standardization in Siddha Medicine.

- 13.1 The committee noted the creation of standardization cells in TASUDMA, Chennai.
- 13.2 Creation of Standards Club: As per BIS the standard clubs are being established with an objective to sensitize young members of society about the importance of standards in improving quality of life. Each Standards club comprises of a Science Teacher as its Mentor and a minimum of 15 students as the members. The committee was informed about creation of standards club in National Institute of Siddha and Government Siddha Medical College, Chennai. The members were requested to make outreach efforts to other Siddha Educational Institutions, so that more standard clubs can be created in pursuance of the current BIS target of opening 10,000 standard clubs.
- 13.3 The committee was informed about the office order regarding the Effective Implementation of the Process Reforms Aimed at strengthening the standardization ecosystem in the Country as issued by the BIS and informed through Annex. I of the agenda.
- 13.4 The committee was apprised of the revised Guidelines for Research & Development project for formulation and review of Standards. The committee members were requested to submit an R&D project on any new emerging area in which they have expertise for the standardization works for the consideration of the sectional committee.
