# ITEM 0 WELCOME AND OPENING REMARKS

- **0.1** Dr. Raghavendra Naik, Scientist C/Deputy Director, BIS welcomed all the panel Members to the meeting and delivered a brief lecture on BIS, standard formulations activity and ongoing Ayush related standardization activity in BIS and ISO.
- **0.2** Dr Praveen Chaudhary, Convener, AYD 01/Panel 2 delivered the introductory remarks and highlighted the importance of developing standards for Ksharasutra and related subjects.

#### ITEM 1: DRAFT INDIAN STANDARDS ON KSHARASUTRA

- **1.1** The panel discussed regarding the preparation of preliminary drafts on following two aspects related to Ksharasutra.
  - a. Ksharasutra (Part 1): Specification for preparation of Ksharasutra
  - b. Ksharasutra (Part 2): Product specification

- **1.2** After discussion, the panel suggested that, instead of two different standards, one standard can be made by including a clause specifying Ksharasutra preparation method.
- **1.3** It was decided to prepare a working draft initially, by referring Ayurveda Formulary of India, ICMR publications and other authentic publications. All the panel members were requested to share relevant documents for preparation of working draft within 15 days. The working draft will be discussed in the next panel meeting to finalize it for distribution among members of Ayurveda Sectional committee.
- **1.2** The panel also advised that the following points shall be considered while finalizing the standard.
  - The standard method of preparing kshara and the type of kshara (Mridu, Madhyama,
     Tikshna) to be used for Ksharasutra preparation.
  - Species of Snuhi to be used for method of collection of Snuhi kshira.
  - A standard for Ksharasutra cabinet.

The panel recommended to explore the possibility of developing separate standards for above subjects through concerned panels/working groups.
