MINUTES

ITEM 0 WELCOME

- **0.1** The Member Secretary welcomed all the members to the Fifteenth meeting of LITD 16. After introduction of the members, the Member Secretary requested the Chairperson to kindly deliver his welcome address and initiate the proceedings.
- **0.2** Shri U K Nandwani extended warm welcome to all the members present and requested all the members for their effective and constructive contribution in standardization activities of the committee. He expressed that it had been a long time since the committee had met and emphasized on the importance of active participation of the members in the committee meetings. He urged members to contribute meaningfully to the formulation of standards under this committee.
- **0.3** He then requested member secretary to carry on with the further agenda items.

ITEM 1 FORMAL CONFIRMATION OF THE MINUTES OF THE LAST MEETING

1.1 Member Secretary informed that the minutes of the fourteenth meeting of the Identification & Data capture techniques, Cards & Security Devices sectional committee held on 26 May 2022 were circulated No comments were received on the minutes. The committee formally confirmed the minutes.

ITEM 2 SCOPE & COMPOSITION OF SECTIONAL COMMITTEE

- **2.1** The committee noted the following scope of the committee-Standardization in the area of:
 - **a**) Smart Cards, Identification cards, security devices and interface associated with their use in inter-industry applications and international interchange.
 - **b**) Data formats, data syntax, data structures, data encoding, and technologies for the process of automatic identification and data capture and of associated devices utilized in inter-industry applications and international business interchanges and for mobile applications.
- **2.2** The Committee considered the composition of "Identification & Data capture techniques, Cards & Security Devices Sectional Committee, LITD 16" and its panel/working groups as given at item 2.2 of the agenda and decided to make the following changes in the composition:
 - **2.2.1** Withdraw the following organizations from the Sectional Committee:
 - 2.2.1.1 Apple India Private Limited, Bengaluru
 - 2.2.1.2 Canon India Private Limited, Gurugram
 - 2.2.1.3 Central Institute of Plastics Engineering and Technology, Murthal
 - 2.2.1.4 HP India Sales Private Limited, Bengaluru
 - 2.2.1.5 National Payments Corporation of India, Mumbai
 - 2.2.1.6 RENSAR Electric Private Limited, Bengaluru
 - 2.2.1.7 Tata Consulting Engineers Limited, Navi Mumbai
 - 2.2.1.8 UL India Private Limited, Bengaluru
- **2.3** The committee decided that organizations who have neither participated regularly in three meetings nor contributed by way of commenting on any of the documents would be once again requested to consider active participation in the committee work and if required fresh nominations may be sought.
 - 2.3.1.1 Computer Society of India, New Delhi
 - 2.3.1.2 Controller of Certifying Authorities, Ministry of Electronics and Information Technology, New Delhi
 - 2.3.1.3 Delhi Integrated Multi-Modal Transit System Ltd, New Delhi
 - 2.3.1.4 Delhi Metro Rail Corporation Limited, Delhi
 - 2.3.1.5 Ministry of Electronics and Information Technology, New Delhi

The committee also decided that in case of no response from such organizations, the organizations would be recommended for withdrawal in consultation with the chairperson LITD 16.

- 2.4 Member Secretary informed that nominations are still awaited from Ministry of Housing and Urban Affairs (MoHUA) and Ministry of Road Transport and Highways (MoRTH). The committee decided to again approach them for nomination of members. It was suggested to reach out to Ministry of External Affairs (MEA) as well for their participation.
- **2.5** It was further decided by the committee to reach out to The India Electronics and Semiconductor Association (IESA) for their participation in the Sectional Committee.

- **2.6** The committee decided regarding the co-option requests as follows:
 - **2.6.1** Mr. Shreenivas Hegde, CTO, Secure Machines Pvt Ltd: It was felt that the domain area of Secure Machines Pvt Ltd is not relevant to the committee scope of work and hence their cooption request was rejected.
 - **2.6.2** Mr. Dinesh Chand Sharma, Director, Standards & Public Policy, EU Project SESEI: The committee felt that the experience and profile is not relevant to the scope of work of the committee. Further there was no response from over email correspondence and hence their cooption request was rejected.
 - **2.6.3** Mr. Ajay Rao, ZEBRA Technologies India Pvt Ltd.: The committee decided to co-opt the member as the organization work area was felt relevant.
 - **2.6.4** Mr. Samson Purre, Kyros Soft Tech Limited: As there was no response from the organization over email correspondence and it appeared that they have moved in to different sectors. Hence their cooption request was rejected.
 - **2.6.5** Mr. Vishnu Vyas, Dupont: Dupont was invited to the meeting for presentation regarding the contribution expected from them but they did not respond or attended the meeting. The domain of the said organization was also felt not compatible with the committee's scope of work and hence the cooption request was rejected.
- 2.1 The committee decided the following changes in the composition of its subcommittee LITD 16:1
 - **2.1.1** Co-opt Mr Nakul Patel, Shreenath Smart Technologies Private Limited, Ahmedabad.
 - **2.1.2** Shri Madhusudhanan Sampath, Infineon informed that Shri Shreenivas Hegde is no longer associated with the said organization and requested that he mane be removed. The committee agreed and asked to send revised nominations.
- 2.2 The committee also decided the following changes in the composition of Panel 4 :
 - 2.2.1 Committee suggested to co-opt members from Indian Common Criteria Certification Scheme (IC3S), operated by STQC (IC3S) from Standardization Testing and Quality Certification (STQC). It was suggested to write to Shri Suresh Chandra Head(IC3S) seeking his interest in contributing to the committee work.
 - **2.2.2** Co-opt Shri Manish Verma, CDAC
 - **2.2.3** Co-opt Shri Madhusudhanan Sampath, Infineon in lieu of Shri Shreenivas Hegde as he has left the organization and.
 - **2.2.4** Co-opt ST Microelectronics Private Limited, Greater Noida.
 - 2.2.5 Co-opt Samsung India Electronics Private Limited, New Delhi
 - **2.2.6** Committee also suggested to seek Nomination from NIC to be co-opted in the panel.
- **2.3** Updated composition along with participation status is given at <u>ANNEX 2</u>.

ITEM 3 RECENTLY PUBLISHED STANDARDS

- **3.1** The committee noted the information as given at Item 3.1 of the Agenda.
- **3.2** The committee requested Shri U K Nandwani to review IS 14173 (Part 2): 2022 (Identical To: ISO/IEC7812-2:2017) Identification cards Identification of issuers Part 2: Application and registration procedures, to ensure that the registrations

mentioned herein are applicable globally as well as at Indian level while drawing the reference to the Mandatory registration scheme for electronic products of MeitY.

ITEM 4 PROGRAM OF WORK OF LITD 16

- **4.1.** The committee noted the information as given at Item 4.1 of the agenda.
- **4.2.** The committee suggested to peruse the list of published standards to ensure that the standards are in relevance to the scope of work. The members were requested to go through the POW and share their comments over email.
- **4.3.** It was decided to take up the review of standards in the next meeting.

ITEM 5 ACTIVITITES OF THE SUBCOMMITTEES/PANELS UNDER LITD 16

- **5.1.** Sub Committee LITD 16: 1 'Cards and personal Identification': A presentation was given by Ms Savita Kashyap, CDAC in which she informed updates with respect to the development of IS 16995 series.
 - **5.1.1.** It was informed that an amendment to IS 16995 (Part 2) is ready to be circulated to all the members for their comments and subsequently for its adoption.
 - **5.1.2.** The committee was also informed that another standard in the series IS 16995 (Part 3) for Test Suites is also ready. CDAC was requested to share the document for circulation to committee members.
- **5.2. LITD 16/P3- National Common mobility card (NCMC) Ecosystem:** This panel had been formulated at the request of MoHUA for working on the standards in NCMC ecosystem. However, the Panel is currently not active due to lack of response at their end. Since in principal the conceptual relevance still exists for such standards, the committee decided to approach MoHUA regarding the need of the standardization regarding the relevance of need at National Common Mobility Card Ecosystem. It was suggested that BIS can approach MoHUA Based on their response the Panel can be reviewed.
- **5.3. LITD 16/P4- Guidelines on issuance of composite certification:** A presentation was given by Ms Savita Kashyap, CDAC on behalf of Panel 4 regarding the progress with respect to adoption of the SCOSTA test suites used by NIC as Indian standards and the concept of composite certification which was greatly appreciated by the Committee.
 - **5.3.1.** During discussion the matter of a composite certification, especially for epassports, was deliberated. It was stated that flash is a common mode of OS rather than ROM–based OS in modern chips. The chip manufacturer therefore provides a chip that carries a skeleton software in ROM to run an OS from the flash after its validation.
 - **5.3.2.** It was further deliberated that the hardware (including the skeleton software) typically achieves EAL 5+ certification.
 - **5.3.3.** Prof. Moona mentioned that this skeleton software is akin to boot loader in general procedure operating systems.
 - **5.3.4.** For a greater competition, multiple OS vendors and chip vendors are desired to be eligible for solution. Since the OS is typically not by the chip vendor and a general purpose software can't reach EAL 5+ certification, the chip + skeleton software + OS cannot be EAL 5+ certified.

- **5.3.5.** The composite certification therefore is applicable on chip + skeleton software in case of flash based components.
- **5.3.6.** It was further stated that the OS functionality is tested for behavioral correctness by certification process of STQC/NIC. It is therefore in the interest of security and larger participation that OS certification be out of the scope of CC such that the chip + loading software can be of higher level of certification (EAL 5+).

Further, the committee requested Prof Moona once again to review the above series of documents and submit a recommendation on the adoption of these documents before the next meeting of the committee. He informed that he would be able to provide inputs based on the review in the next meeting of the committee.

He further informed that India has its own Specification of Indian Driving License that should be perused and reviewed by the committee for adoption as Indian Standard Specifications (ISS) instead of these International standards that were published much later. It was decided to discuss the matter with the concerned ministries and relevant departments such as NIC, MoRTH and MoHUA. It was decided by the committee to take these up in the next meeting.

ITEM 7 INTERNATIONAL STANDARDIZATION ACTIVITIES

- **7.1.** The committee noted the information given under item 7.1 of the agenda.
- **7.2.** The committee noted the information given under item 7.2 of the agenda. The chairman emphasized on active participation of the members in ISO working groups. He instructed members to attend the meetings and to make a practice of submitting report to BIS regarding the same in continuation to our participation as a "P" member in these Sectional Committees at ISO/IEC. In this regard, the committee reviewed the list of experts nominated in various WGs of SC 17 & 31 given in Annex 6 of the agenda and further Nomination were sought. The following nominations were decided to be registered as experts and document monitor during the meeting:
 - 7.2.1. Mr. Nakul Patel as an expert in the SC17/WG 1, SC17/WG 3, SC17/WG 4, SC17/WG 8, SC17/WG 10 and SC17/WG 11.
 - **7.2.2.** Mr. Madhusudhanan Sampath as an expert in SC17/WG 11.
 - **7.2.3.** Mr. Rajesh Kushwaha, CDAC as an expert in SC17/WG 4.
 - **7.2.4.** Ms. Jyoti Kushwaha as expert in SC17/WG 3, SC 17/WG 4, SC 17/WG8, SC 14/WG10, & SC31/WG 2
 - 7.2.5. Ms. Jyoti Kushwaha, Member Secretary in the SC 17/AG 1, SC 17/AG 3, SC 17/WG 1, SC 17/WG 11, SC 17/WG 12, SC 31/WG 1, SC 31/WG 2, SC 31/WG 4 and SC 31/WG 8 as document monitor.

- **7.5.** Further, it was decided to circulate the list of the documents to all members for their inputs.
- **7.6.** The committee noted the information given under item 7.4 of the agenda. The chairperson mentioned that it was of utmost importance that the ballot documents may be reviewed by the members and comments on the same were furnished and

ensure our participation as "P" member of the respective SCs of ISO.
