Item 2 SCOPE AND COMPOSITION OF SSD 14 SECTIONAL COMMITTEE

2.1 Scope

The present scope of the Drinking Water Supply, Wastewater and Stormwater Systems and Services Sectional Committee, SSD 14 is given below:

'Standardization of the management concepts for service activities and processes relating to drinking water supply, wastewater and stormwater systems.

This structure includes activities necessary to fulfil the objectives of water supply, wastewater and storm water systems. Water supply for purposes other than drinking water can be included in this management concept structure.

Excluded:

- Normative target or threshold values for service quality criteria;
- Normative limits of acceptability for drinking water quality or for wastewater and storm water discharges to the environment;
- Product specifications for chemical and biological additives for water andwastewater

treatment;

- Standardization in sludge recovery, recycling, treatment and disposal;
- *Standardization in water reuse*;
- Methods for the measurement of water quality.'

Liaison with: ISO/TC 224 – Service activities relating to drinking water supply, wastewater and stormwater systems.

The Committee may review the scope.

Item 5 R& D PROJECT UNDER SSD 14

As per the direction of DG BIS, no Standard/Revision of Standards shall be formulated without research. The following subjects have been identified by BIS to conduct R&D under SSD 14.

5.1 Decentralized Wastewater Management (DWM) Systems

The outcome of the R&D project will help SSD 14 to develop an IS standard on DWM systems. The terms of reference for the R&D project on onsite domestic wastewater services is attached in **Annex D**.

5.3 Mobile Toilets During Public Health Emergencies

ISO/TC 224 is developing international standards on mobile toilets during public health emergencies and SSD 14 is actively participating in drafting the documents by providing comments. Currently, participation of SSD 14 is limited and for its further enhancement, it is proposed to conduct an R&D project on this subject to get more information. The outcome of the R&D project will help SSD 14 to increase participation in international standardization. The terms of reference for R&D project on onsite domestic wastewater services is attached in **Annex E**.
