We are writing this to inform you regarding malicious agenda of the trader/Chinese yarn importer cartel to defame Indian industry and once again create pressure on government to rethink about implementation of BIS in polyester mother yarns and POY/FDY.

We have come across news article, which are surely planted by such cartel in certain Gujarat newspaper, articulating false claims that price of mother yarn has gone up after implementation of BIS. This cartel is blaming Indian industries for such price rise and also blaming that certain industrial houses are profiteering from such price rise. However,

reality is totally different as there is negligible increase in price of mother yarn produced and marketed by Indian industry and high price rise is done by these traders/importers only. We have shared data of prices of mother yarn sold by Indian industry and traders/importers before and after implementation of BIS as per attached Annexure A. Thus, it is clear that there is no actual rise in the price of mother yarn post implementation of BIS. Whatever claims are made are result of importer/trader cartel profiteering from helplessness of weavers on such importers/traders as single order of fabric requires same batch/lot of yarn for completing the export order.

Mother yarn consumption accounts for below 1% in total polyester yarn consumption. There is no issue on part of rest 99%. This all vicious propaganda is spread only for 1%. Thus, it is clear that all this false propaganda is spread for the benefit of only few Chinese yarn importer/trader cartel members.

There is no shortage of mother yarn as supply from Indian industry is higher than demand from domestic weavers. Indian industry have to export additional quantity after supply to Indian weavers with 80% efficiency. Thus, there is additional supply of polyester mother yarn as compared to demand and accordingly there cannot be any real reason for price rise. Moreover, there is huge rise in the price of grey fabric post implementation of BIS. Comparative data is shared with this letter as per attached Annexure B. Thus, weaver community is also getting benefitted

1. Rumour – “ Quality of polyester mother yarn manufactured by Indian manufacturers is weak as compared to Chinese polyester mother yarn “

Reality - This is totally false propaganda. Following are the correct and factual details :

- i. All Indian manufacturers of mother yarn are having BIS certification. If such false accusations are made, it directly challenges the authenticity of BIS approvals and the government bodies itself.
- ii. Polyester mother yarn manufactured by Indian industry is exported to highly developed markets like Europe, South Korea, Asian Countries and Middle East regularly. These all countries required high quality standards as known to the government. This clearly establish, without any doubt, that Indian manufacturers are manufacturing highest quality mother yarns which is widely accepted around the globe. We have attached proof of export document by manufactures of polyester mother yarn.
- iii. Before Covid-19 second wave in the year 2021, there was no import of Chinese polyester mother yarn at all. Due to slow down in Chinese industry, there is no demand for Chinese polyester mother yarns in China. Hence, factories in China became idle and there is huge stockpile of polyester mother yarn in China. So, with a view to dump these stocks to India,

polyester mother yarn from China started to be imported to India, with the help of greedy traders in India.

- iv. Real consumers of polyester mother yarn both Indian as well as foreign, i.e. weavers/knitters, have always appreciated quality of Indian manufactured polyester mother yarn. We are forwarding copy of letters issued by such Indian and foreign weavers/knitters acclaiming quality of Indian manufactured polyester mother yarn.
- v. Quality of Indian manufactured polyester mother yarn is fully compliant with all parameters of BIS. We have attached copy of certificate of technical analysis and lab testing results data to demonstrate that we are manufacturing polyester mother yarn as per quality standards stipulated by BIS.

2. Rumour – “ Indian manufacturers are not having enough capacity to supply material as per domestic demand “

Reality – We have supplied data showing capacity of Indian manufacturers. It is well settled that Indian manufactures of polyester mother yarn are having capacity to produce polyester mother yarn more than domestic demand.

- i. There is no shortage of mother yarn as supply from manufactures of polyester mother yarn is higher than demand from domestic weavers/knitters. Indian industry have to export additional quantity after supply to Indian



weavers/knitters. Thus, there is additional supply of polyester mother yarn as compared to demand. Capacity of Indian polyester yarn manufacturers is 7400 MT per month, as against that, demand from domestic weavers/knitters is 3470 MT per month only.

- ii. To put this fact in data format, idle stock of polyester mother yarn at our factory has never gone below 500 MT as per statutory records. There is 500 MT stock at our factory as on date.

3. Rumour – “Yarns produced by Indian manufactures are not having equal weightage. So, there is wastage of yarn due to unequal weight/length”

Reality - This is real gimmick played by vicious Chinese yarn trader cartel. Correct situation is as below :

- i. We are exporting polyester mother yarn around 400 to 500 MT since 2018. For export, only polyester mother yarn with equal weight is required. Since we are exporting polyester mother yarn since so long and never faced any such hilarious question from our clients, this propaganda is totally false. We have attached copy of export documents as mentioned above.
- ii. It is clear that domestic polyester yarn manufacturers are continuously supplying equal weight yarns since long. There is acceptance of such yarns domestically and internationally.

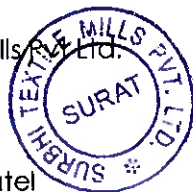




