#### ITEM 0 OPENING REMARKS OF CHAIRPERSON

The Chairperson Shri P. Bhagat Singh introduced himself then extended a warm welcome to all the members to the twenty-seventh meeting of the committee and appreciated the interest shown by them in the work of the Committee and their contribution to the national standardization effort. He along with all the other members of the committee thanked Shri D S Sachdev former chairperson of this Committee for his excellent contribution over the years.

Being first meeting as the chairperson, he requested all the members to introduce themselves. Thereafter the member secretary took up the item-wise agenda.

#### ITEM 1 CONFIRMATION OF THE MINUTES OF THE LAST MEETING

There being no comments on the Minutes of the last (Twenty-sixth) meeting of the Building Construction Practices Sectional Committee, CED 13 was held on 16th October 2023 via video conferencing, as circulated vide BIS DG letter no.
