ITEM 0 GENERAL

0.1 Welcome Address by BIS

Shri A.R.Unnikrishanan, Sc-G and Head (MHD), welcomed all the members to the 17th meeting of Medical Equipment & Hospital Planning Division Council.

He informed that 2023 has been a year of transformation in BIS. Lots of changes have happened in all activities in BIS. He highlighted the process reforms in Standardization which were implemented with the purpose of elevating BIS to the level of one of the best SDOs in the world.

With the approval of National Medical Devices Policy, 2023, the role of BIS as Standards Setting Body has been enhanced. Various responsibilities have been assigned to BIS in order to ensure that there are Indian Standards for various categories of Medical Devices. Medical Equipment and Hospital Planning Department (MHD) has also come into the limelight with its efforts on national and international standardization activities.

He emphasized on the important initiatives undertaken by BIS to improve efficiency of the Technical Committees. He expressed happiness over the improvement in participation by the Technical Committee members during the last few months.

He said that lot of Standards Development activities are happening in MHD with the active support of Officers, contributions by Committee Members, Experts and Chairs of TCs as well as guidance of MHDC through its members and Chair. He expressed his deep gratitude to all for their extensive support in the national standards setting process.

He concluded by saying that there are lots of duties and responsibilities that need to be fulfilled by every individual while being a part of BIS for Standards Development, which would highlight the commitment of BIS towards achieving the objectives of UN SDG 3.

0.2 Opening Remarks by Chairperson

Dr. Chander Shekhar, Chairperson, appreciated and praised BIS for its commitment towards standard formulation. He appreciated the improvement in the quantum of work of MHD wrt the documents under development at various stages.

He was also happy note that MHD is actively involved in spreading awareness on the standardization efforts to different sectors within and outside the country through various programmes including active participation in international standardization.

He expressed appreciation towards officers, chairpersons, and committee members for their diligent efforts, recognizing their indispensable contributions to the accomplishments of various Technical Committees in MHD.
