ITEM 7 NEW SUBJECTS

7.1 The committee may identify the emerging fields in the area under its scope and decide formulation of Indian Standards on the same. The Committee may also define thrust area which should take into consideration the standards development required in the given context keeping in view the social, environmental and economic consideration.

- 7.2 A brief discussion was held with the chairperson regarding the priority subjects for standardization. The Chairperson has suggested Veterinary ophthalmology as a priority area comprising the following subjects which can be considered for standardization
 - 7.2.1 Tonometer to measure IOP in animals
 - 7.2.2 Hand held slit lamp biomicroscope
 - 7.2.3 IOL for dogs and cats
 - 7.2.4 Keratometer for dogs and cats
 - 7.2.5 Aesthesiometer for Corneal reflex test
 - 7.2.6 A-scan ocular ultrasound
 - 7.2.7 B. scan ocular ultrasound
 - 7.2.8 20 to 50 D condensing lens
 - 7.2.9 Intrascleral Prosthesis (ISP)
 - 7.2.10. Biosynthetic corneal implants 11. Glaucoma Valve Implants
 - 7.2.11. Portable small size Phacoemulsification machine
 - 7.2.12. STT and FDT strips
 - 7.2.13. Direct ophthalmoscope
 - 7.2.14. Hand held ERG machine
 - 7.2.15. Hand held Fundus camera
 - 7.2.16. Advanced operating microscope
 - 7.2.17. Ophthalmic surgery kit

- 7.3 Veterinary Hospitals Standards for minimum requirements
- 7.3.1 A need was felt to formulate a standard on minimum facilities / requirements for Veterinary Hospitals with animal group wise (Small animals, Bovines, Equines, Reptiles, Heavy / Large animals, Avians, Exotic Animals, etc) requirements.
- 7.3.2 Once the minimum requirements are standardized then the device or instruments related to each department and section can be taken up for standardization.
- 7.3.3 It is proposed to form a panel of 4 members to prepare a working draft on minimum requirements for Veterinary hospitals.

ITEM 9 INTERNATIONAL ACTIVITIES

- 9.1 BIS is the founding member of International Organization for Standardization (ISO) and represents India as a permanent member in various Technical Committees.
- 9.2 While going through the areas of work of ISO technical committees, it was realized that there is no technical committee dedicated to Veterinary Care in ISO. There are committees handling subjects such as slaughter houses and food processing but none related to Veterinary Care.
- 9.3 It was also discussed at higher management level of BIS that the best practices followed by various other countries are to be studied and adopted in our standards.
- 9.4 Considering that ISO doesn't have a dedicated Technical Committee for Veterinary Care, India can explore proposing same to ISO.
- 9.5 Before proposing same, BIS officers would be doing a study on the best practices followed by various countries. The members of this committee are requested to advice on the reputed institutions worldwide and contact persons so that they can be approached regarding same.
