Resolution 1 (Item 2.5)

The Committee decided to include Brahad Elastomers Pvt Ltd., Bengaluru as a member of the Menstrual Cups working group.

Resolution 2 (Item 3)

2.1 It was decided to finalize the documents where no comments have been received.

2.2 For the documents on which comments were received, it was decided to circulate the drafts along with the comments for a period of 3 weeks' time.

Resolution 3 (Item 4)

It was decided to take up the revision of following pre 2000 standards:

Resolution 6 (Item 8)

The ISO 19351 for Fallopian Rings is adopted as IS 13009 under MHD 03. As per the issue raised by Mr. Vinod Kumart, Corporate Channels India, an amendment to be issued for Clause 4.3.5 Package Seal Integrity. The option to use of Tyvek pouches for Tubal ring packaging should be continued with the tests as per ASTM F-1929 for permeable packaging.
