**MINUTES**

**ITEM 0 WELCOME**

- 0.1** The Member Secretary welcomed all the members to the Twentieth meeting of LITD 15. After introduction of the members, the Member Secretary requested the Chairperson to kindly deliver his welcome address and initiate the proceedings.
- 0.2** Shri Ramesh Radhakrishnan, extended warm welcome to all the members present and requested all the members for their effective and constructive contribution in standardization activities of the committee. He emphasized on the importance of active participation of the members in the committee meetings. He also requested committee members to review the published standards at ISO level in the domain corresponding to LITD 15, for relevance and adoption as Indian standards. He urged members to contribute meaningfully to the formulation of standards under this committee and increase our reach to Working Groups where our presence is not reflected at International level.
- 0.3** He then requested member secretary to carry on with the further agenda items.

## **ITEM 1 FORMAL CONFIRMATION OF THE MINUTES OF THE LAST MEETING**

**1.1** The committee formally confirmed the minutes of the last (19th) meeting of Data Management System Sectional Committee, LITD 15, which was held on 03 November 2023 were circulated vide email dated 19 Dec 2023.

## **ITEM 2 SCOPE & COMPOSITION OF SECTIONAL COMMITTEE**

**2.1** The committee noted the following scope of the committee:

Standardization in the area of:

- a) Data Management and Interchange
- b) Document Description and Processing Languages
- c) Programming languages, their environments and system software interfaces

**2.2** Members also discussed regarding the work in ISO/TC 171/SC 2 - Document file formats, EDMS systems and authenticity of information which has published 39 standards and working on 5 standards that seem relevant to the scope of the committee. Members were requested to go through the scope and list of documents of the subcommittee to identify its relevance to the existing scope of LITD 15. It was informed that TC 171 -Document management applications is represented by MSD 05-Documentation and Information Sectional Committee of BIS.

**2.3** The committee accepted the nomination of Mr. Rajeev Srivastava as an Alternate Member from CDAC, Mumbai. The updated composition is given in [ANNEX 2](#).

**2.4** The committee decided to formulate a new Panel LITD 15: P1 to review and analyse the international standards published by SC 22, SC 32 and SC 34 of ISO/IEC JTC1 for evaluating their suitability for adoption as Indian Standard. It was decided to circulate an email seeking volunteers for the panel.

**2.5** The committee also decided to formulate a new Panel LITD 15: P2 to review and analyse the international standards under development in SC 22, SC 32 and SC 34 of ISO/IEC JTC1 for effective contribution in International standardization. This panel would also be responsible for formulating national opinion on various ballots issued by the above mentioned SCs. It was decided to circulate an email seeking volunteers for the panel.

**6.3.** The committee further deliberated on the matter of standardization with respect to language domains such as Python, Rust, Java, Ruby etc. which are not directly listed in ISO committees but being utilized by the industry, particularly Indian industry at large. Members were requested to identify experts from such areas for seeking further inputs.

**6.4.** The committee noted the list of published standards by corresponding ISO/IEC JTC 1 SCs are given at ANNEX 5 of the agenda and decided to formulate a new Panel LITD 15: P1 to review and analyses the international standards published by SC 22, SC 32 and SC 34.

**6.5.** The Committee noted the various standards under development by corresponding ISO/IEC JTC 1 SCs are given at ANNEX 6 of the agenda and decided to formulate a new Panel LITD 15: P2 to review and analyses the international standards under development in SC 22, SC 32 and SC 34
