Please find below my participation report at the SC 42 meeting in Seoul, South Korea.

At the very outset, I am very thankful to the BIS, Honourable Chairman and members of LITD 30, for giving me the opportunity to participate in the SC 42 plenary meeting. Following points summarize my participation and contributions in the meetings of SC 42.

1. Attended SC 42 opening ceremony, listened to the presentation by Dr. Anantaram sir on Reliability
2. On April 24, 2024 morning session Participated in the overview discussions on two ongoing projects currently registered in JWG 5. In the meeting it was asked if I can volunteer as liaison officer between SC 42 and ISO/TC 46. I agreed for the same and it was approved by SC 42 minutes of the meeting is reproduced as follows, [Resolution 339 (26.April.2024.Seoul) SC 42 establishment of a Liaison with ISO/TC 46 Information and documentation. SC 42 approves the establishment of a liaison with ISO/TC 46, Information and documentation, and assigns Lauriane Aufrant (France) and **Mohammed Javed (India)** as the liaison representatives from SC 42 to ISO/TC 46. The same received support from Canada and the other members had no objection to it.]
3. On April 24, 2024 afternoon session Participated in the discussions of the project ISO/IEC AWI TR 23282: Evaluation methods for accurate natural language processing systems by Rania Wazir as editor. In the meeting myself and Tom Lebrun (Canada) will contribute for Transparency of tradeoff - JWG5 item of action. In the meeting it was also agreed to contribute an evaluation metric table along with characteristic features jointly with Elaine Newton (US) and Frank (USA).
4. On April 25, 2024 whole day there was discussion on the ongoing project - ISO/IEC AWI TR 23281 Artificial intelligence — Overview of AI tasks and functionalities related to natural language processing, many points were raised in the project discussions to give the document a good shape. The whole draft document was presented in front of the expert members, the contribution to this document can be submitted online or can be proposed in the upcoming virtual meetings.
