Thank you to the participants of the meeting. Following are the major decisions of the today's meeting(20 May 2024):

1. All co-option requests would be included as invitee. Based on their contributions decision for co-option would be taken in sub-subsequent meetings. Member Secretary would also seek clarification as suggested by the committee.
2. Dr. C Anantaram, Dr. Syed Ahmad, Mr. Raghvendra Bhat, Mr. Srinivas P and Mr. Kshitij Bathla provided update related to the present status of 'Reliability of AI systems', 'India's study item- Guidance for Generative AI Applications', 'ISO/IEC WD TS 17847 'Verification and Validation Analysis of AI Systems', 'ISO/IEC WD TR 42106 'Artificial Intelligence — Overview of differentiated benchmarking of AI system quality characteristics' and 'De-identification of training data for ML' respectively. Members of LITD 30, LITD 30/WG were specifically requested to contribute to these projects.
3. Documents due for India's inputs:
 - a. To vote approval for 'ISO/IEC FDIS 5259-1', 'ISO/IEC FDIS 5259-3' and 'ISO/IEC FDIS 5259-4'.
 - b. To confirm SR ISO/IEC 20546:2019 Information technology — Big data — Overview and vocabulary
 - c. To Disapprove 'ISO/IEC NP TS 42112 Information technology — Artificial intelligence — Guidance on machine learning model training efficiency optimisation'. It was decided to finalize comments for disapproval based on inputs of 'Dr. Pushpak Bhattacharyya', Mr. Raghvendra Bhat and Mr. Sundar Narayanan. All were requested to provide their comments in writing to finalize comments.
 - d. For other documents, all were requested to share their inputs at the earliest to finalize inputs in the respective meeting of LITD 30/WG.
4. All registered experts were specifically requested to contribute and to provide regular updates to LITD 30. It was decided that based on their contributions, registered experts would be reviewed in consultation with the LITD 30 Chairperson. Member Secretary would also share updated list of under development documents of JTC 1/SC 42.
5. Members were requested to review the list of SC 42 published standards and to suggest standards that can be taken up for adoption as Indian Standard. Members were requested to share inputs by 30th May 2024.
6. Delegates de-briefed the committee regarding their participation. It was decided that member secretary would discuss with LITD 30 Chairperson to finalize venue for hosting of JTC 1/SC 42 meeting in India during April 2025.
7. It was decided to finalize documents [LITD/30/24566 (Identical To: ISO/IEC 42001:2023), LITD/30/24866 (Identical To: ISO/IEC 5338:2023), LITD/30/24862 (Identical To: ISO/IEC TR 5469:2024), LITD/30/24867 (Identical To: ISO/IEC TS 25058:2024), LITD/30/24865 (Identical To: ISO/IEC 5339:2024)] for publication as Indian Standards, without any changes. It was decided to resolve the comments received and to recommend changes for discussion at JTC 1/SC 42 meetings.
8. Member secretary would issue review sheets for the documents due for review 2024-25 for further decision.

9. Next meeting would be held at IIT Bombay. Date and time would be finalized in consultation with the Chairperson. Members were requested to inform their convenient day in the week of 2nd to 6th Sep 2024.
10. Members were requested to participate in the respective LITD 30/WG meetings. All meeting links have been shared and now all LITD 30/WG meetings would be held monthly as per the given schedule.
11. Minutes would be issued in due course.
