- 1. Decided to include all co-option requests as invitee. Based on their contributions, the decision for co-option will be taken in sub-subsequent meetings.
- 2. Decided to include Chandigarh College of Engineering and Technology, AI Tech Ethics and Cloud Security Alliance NCR as member in the respective groups of LITD 30/WG/Panel.
- 3. Dr. C Anantaram, Mr. Syed Ahmad, Mr. Raghvendra Bhat, and Mr. Kshitij Bathla provided update related to the present status of 'Reliability of AI systems', 'India's study item-Guidance for Generative AI Applications', ISO/IEC WD TS 17847 'Verification and Validation Analysis of AI Systems',

ISO/IEC WD TR 42106 'Artificial Intelligence — Overview of differentiated benchmarking of AI system quality characteristics' and 'De-identification of training data for ML'. It was informed that meeting of LITD of 30/WG 4 is scheduled on 4th September (2PM-3PM, https://bismanak.webex.com/bismanak/j.php?MTID=m8555bfeee883510543fb8f0473177d70) to discuss India's study item-Guidance for Generative AI Applications. It was also informed that meeting of LITD 30/WG 2 will be planned either on 6th or 9th September to discuss 'De-identification of training data for ML'.

- 4. All were requested to provide their inputs for 'ISO/IEC DTS 12791.2 Information technology Artificial intelligence Treatment of unwanted bias in classification and regression machine learning tasks' by 4th September 2024.
- 5. All were requested to provide their inputs for 'Support to launch a NP Ballot Addressing risks AI systems SC 42 support to launch a NP ballot 'Guidance on addressing risks in generative AI systems'" by 5th September 2024.
- 6. All were requested to provide their inputs for "ISO/IEC NP 25336 Information technology Artificial intelligence High-level framework and guidance for the development of conformity assessment schemes for AI systems" by **10th September 2024.**
- 7. It was decided to support CIB 'launch a NP Ballot Terminology and concepts for domain engineering of AI systems'.
- 8. The committee agreed to suggestions as mentioned in Annex-2. All were given one week time i.e till 10th September 2024 to inform if any change is required. In case of no objections/inputs by 10th September, experts will be removed/registered as per Annex-2.
- 9. It was decided to support Canada's National Body Contribution Creation of a terminology coordination Task group. It was decided that this may be conveyed during the SC 42 meeting however we should not agree to creation on new entity group for this process.
- 10. The committee reviewed the list of standards to be reviewed during April 2024-March 2025 and agreed to the recommendation as mentioned at item 6.2
- 11. The committee agreed to the request for extension of timeline of R&D project "Study of Impacts of Artificial Intelligence on Human Psychology".
