Thank you to the participants of the meeting. Following are the major decisions of the today's (16 Oct 2024) LITD 30 meeting:

- 1. Decided to include all co-option requests as invitee except Mr. Dinesh Chand Sharma and Mr. Gaurav Joshi. Mr. Gaurav Joshi will be included in the additional mailing list. Based on the contributions of the invitees, the decision for co-option will be considered in subsequent meetings. It was also decided to approach Ministry of Electronics and IT for their active involvement and participation in the committee work.
- 2. Dr. C Anantaram, Dr Shrikant Bhat, Mr. Syed Ahmed, Mr Srinivas P, Mr. Raghvendra Bhat and Mr. Kshitij Bathla provided update related to the present status and discussions held related to 'Reliability of AI systems', 'India's study item-Guidance for Generative AI Applications', ISO/IEC CD TS 17847 'Verification and Validation Analysis of AI Systems', ISO/IEC WD TR 42106 'Artificial Intelligence Overview of differentiated benchmarking of AI system quality characteristics' and 'De-identification of

- 3. All were requested to provide their inputs for 'ISO/IEC CD TS 17847 Information technology Artificial intelligence Verification and validation analysis of AI systems' by 5th November 2024.
- 1. Delegates de-briefed the committee regarding their participation in the plenary and working group meetings of SC 42 (7th 11th October 2024). All delegates were requested to share their report of participation as well.
- 5. It was informed that fifteenth plenary and working group meetings of JTC 1/SC 42 are scheduled to be held in India during 31st March 2025-4th April 2025 at India Habitat Centre, Delhi. Members provided their suggestions regarding planning for hosting meetings. All were requested to share their suggestions in writing so that accordingly these may be discussed with LITD 30 chairperson and other interested members.
- 5. The committee agreed to the suggestions of registrations/removal of experts as given in Annex-2.
- 7. It was conveyed that prior participation in SC 42/WGs is required for effective participation of a large Indian delegation to 15th JTC 1/SC 42 plenary and working group meeting (31st March -4th April 2025, India Habitat Centre, Delhi). It was informed that to effectively utilize the benefit and opportunity of Hosting JTC 1/SC 42 meeting in India (April 2025), all members shall start participating in the SC 42/WGs. Member secretary also informed about the recent directions to categroize projects as High/Medim at NP stage and to designate experts for all such projects. All were requested to identify the under development projects (preferably projects at WD/AWI stage) in which they want to contribute. All were requested to inform by 31st October 2024. It was decided that member secretary shall process all such requests for registration as expert after obtaining approval of LITD 30 Chairperson.
- 3. It was decided to initiate process for adoption of ISO/IEC 5259 Series and ISO/IEC 24030:2024 as Indian Standard.
- **).** The committee reviewed the list of standards which are due for review during April 2024-March 2025 and agreed to the recommendation as mentioned at item 6.2.
- 10. The committee agreed to the request to extend the timeline of R&D project "Study of Impacts of Artificial Intelligence on Human Psychology" by one-month. It was decided that progress report will be shared with the committee members for their inputs by 24th October 2024.
