#### Item 1 CONFIRMATION OF THE MINUTES OF THE PREVIOUS MEETING

#### Item 2 REVIEW OF SCOPE AND COMPOSITION OF SSD 08.

**2.1** The present scope of Information and Communication Services Sectional Committee, SSD 08 is given below:

**Scope:** Standardization in the field of information and communication services provided by professional individuals or organizations to other organizations or common people through physical or electronic means for transfer of information such as internal communication, over the top (OTT) services, collaboration tools, user interface and user interaction services, web based application system services, email services, courier services, cloud based communication services and other related services.

#### Excluded:

The communication services as provided by the licensed communication service providers covered under the Indian "Telecommunication Act, 2023" as amended from time to time.

#### Liaison:

- IT and IT enabled Services Sectional Committee, SSD 10
- Media and Entertainment Services Sectional Committee, SSD 13.
- Information System Security and Privacy Sectional Committee, LITD 17

#### The Committee may **REVIEW** on the scope.

#### Item 3 NEW SUBJECTS FOR STANDARDIZATION

During the last meeting, the Committee reviewed and approved the recommendation given by the Panel. Based on the recommendation of the panel, the committee have taken the following decisions:

a) The Committee decided to adopt ISO 14452:2012 Network services billing — Requirements as Indian Standard and circulate the document as a P-draft document for a period of one month.

**Status**: The document completed P-draft circulation on 15 August 2024, after completion of end date no comment has been received.

#### The Committee may **DECIDE** the next course of action.

b) The committee approved the following three subjects for standardization under SSD 08:

#### i. Management Employee communications

- ii. Public notifications of statutes and Regulatory orders
- iii. Third Party Assurance services in Health care

Out of the three subjects approved by the Committee, the Committee prioritized Management-Employee Communication as the first priority. Furthermore, the Committee created Panel SSD08/P-2 to initiate this standardization work. The following members shown interest to be part of the Panel SSD 08/P-2.

In the first meeting of the panel, the panel will identify more relevant experts, study the existing guidelines/documents/SOPs and also decide on the timelines for the formulation of the standard. Once, after making considerable progress on the subject, the Committee decided to take up the other two approved subjects.
