ITEM 0 GENERAL

0.1 Welcome by DDG (Standardization - II)

On behalf of BIS, Shri Sanjay Pant, DDG (Standardization-II) extended a warm welcome to Professor Bharat Bhasker, Chairperson, SSDC, the esteemed members of Services Sector Division Council (SSDC) and the Chairpersons of Sectional Committees present in the sixth meeting of the Council. He highlighted the importance of standardization in the field of services sectors including the Champion Services Sectors identified by the government of India. He shared about ongoing progress and expansion under SSDC since its establishment to meet standardization needs of various services sectors and at present 22 Sectional Committees have been established to meet the demand of the industry and consumers/users as well as other stakeholders. He futher shared that one more Sectional Committees on Cold Chain Logistics is being proposed for consideration and approval of the Council. He further added that Annual Plan for Standardization (APS) 2024-25 has been prepared for each Setional Committee after consultation with the Ministries/Departments and Industry Associations. He added that SNAP 2022-27 has been prepared by BIS after extensive stakeholder consultations and requested the Council to monitor the progress of standardization work mentioned in SNAP document for the desired outcome. He requested



the Chairpersons to keep an eye on the subjects identified in the APS 2024-25 and monitor the progress of work so that standards are formulated within the timelines. He also highlighted the recent initiatives taken by BIS including launch of research projects on subjects identified for standardization with BIS funding, to support formulation of evidence based Indian Standards and further requested the members to take up the reseach projects on already identified areas as well as identify new areas/subjects for research, where needed. He also shared about BIS initiatives to boost standardization efforts including capacity building programmes for newly inducted members/Chairpersons of Sectional Committees being conducted on regular basis at BIS, NITS, Noida. He also informed that BIS has signed MoUs with more than 90 reputed educational institutions of India to collaborate in standardization activities and initiated the activities, such as sensitization of faculty members and students about standardization, inclusion of standardization as topic in the curriculum, creation of standardization clubs in the institutes, their active participation in technical committee meetings, taking up research projects, and jointly organizing Seminars/Webinars/Conferences. He also apprised the Council about series of lectures on important subjects on standardization being delivered by BIS officers for faculty and students of the institutions.

He appreciated the efforts of the Chairpersons of Sectional Committees for providing effective leadership and requested for continued guidance for development of world-class standards in emerging areas in various services sectors.

He wished all success for deliberations to follow.

0.2 Opening Remarks by Chairman, SSDC

Professor Bharat Bhasker, Chairman SSDC extended a hearty welcome to all the members of the Service Sector Division Council, SSDC, Shri Sanjay Pant, Dy Director General (Standardization), BIS and Chairpersons of the Sectional Committees. He shared that SSDC started the standardization activities in 2020 through its first meeting held on 25 February 2020 and created 13 Sectional Committees in various Champion Services Sectors and with the expansion in the activities under SSDC, 9 more Sectional Committees have been created in last 3 years and presently 22 Sectional Committees are functioning and a proposal for creation of one more Sectional Committee on 'Cold Chain Logistics' would be discussed in this meeting. He highlighted the important standards published under various Sectional Committees and appreciated the efforts of experts and potential available in the country to deal with standardization work in services. He appreciated BIS approach to consult Central Government/Departments and Industry Association while preparing the 'Action Plan for Standardization (APS) 2024-25'. He shared with the Council that subjects, taken up for standardization under various Sectional Committees under APS 2024-25, are very important as well as relevant to the service sectors industry and other stakeholders which would definitely help them to further improve the level of quality of services and creating quality ecosystem in services in the country.

Professor Bhasker stated that the Sectional Committees established under SSDC have been functioning actively and congratulated all the Chairpersons, Conveners and members of Sectional Committees, Subcommittees, Panels and Work Groups for their contribution in



standardization activities in Services Sectors. He expressed his satisfaction that 166 Indian Standards had been formulated by the Sectional Committees under SSDC and number of documents are under development at various stages.

The Chairperson expressed his pleasure that Indian participation in international standardization activities has enhanced in past one year and experts are actively participating in international meetings of ISO Technical Committees and providing comments on ISO documents on regular basis. He appreciated and congratulated the Indian experts for taking positions of Convenorship of various Working Groups in ISO Technical Committees. In continuation to this he stated that a proposal from India to set up new ISO Committee on 'Fundamental of Services' recommended by Basic standards on Services, SSD 19, would be discussed in this meeting.

He appreciated the efforts of Chairs and members of Sectional Committees, Panels and Working Groups who have made significant contribution in the standardization work at national level as well as international level.

He requested all the esteemed members of the Council and the Chairs of the Sectional Committees to actively participate in the proceedings of SSDC today and provide suggestions to further improve the standardization activities in services to enable to move forward in more efficient and effective manner

With these words, he requested the Member Secretary to take up the agenda items of the sixth meeting of SSDC.

ITEM 3 SCOPE AND COMPOSITION OF SERVICES SECTOR DIVISION COUNCIL

- **3.1** The Council reviewed the present Scope and Composition of Services Sector Division Council as given in Annex B of Agenda along with status of attendance in the last three meetings of SSDC. After the review, the Council confirmed the present scope of SSDC and while deleberating on the composition, the Council decided the following:
- **a) AIIMS, New Delhi** The membership dropped due to non participation in the meetings of SSDC and decided to offer membership to similar organization such as AIIMS, Rishikesh or Maulana Azad Medical College, Delhi.
- **b)** Consumer Voice Fresh nomination from Consumer Voice would be communicated shortly (as informed by Shri M.A.U. khan) to BIS to update the records of composition of SSDC.
- c) Ministry of Civil Aviation Member Secretary to seek fresh nomination from the ministry as nominated members are superannuated.
- **d)** Ministry of Commerce and Industry, Department of Commerce Shri Darpan Jain, JS, has replaced Shri Vipul Bansal, JS, as informed by them.
- **e) Ministry of Finance** Member Secretary to seek fresh nomination from the Ministry of Finance as the nominated alternate member, Shri Anang Rawat (Asstt. CGA) is informed to be transferred.
- f) Ministry of Jal Shakti Fresh nominations are required because of transfers of nominated members.
- **g) Ministry of Skill Development** Member Secretary to send another reminder requesting to attend meetings of SSDC and provide fresh nomination in case of change in nominated officials.
- h) Ministry of Tourism Member Secretary to seek fresh nomination as the nominated member is presently not associated with the Ministry of Tourism.



- i) NBCC (India) Limited, New Delhi Member Secretary to seek fresh nomination as the nominated member is presently not associated with the organization.
- **j) NABHHP** Member Secretary to seek fresh nomination as both the nominated members are presently not associated with the organization.
- **k)** National Water Mission Mr Anuj Kanwal informed the Council that he is representing Department of Water Resources, RD & GR, Ministry of Jal Shakti and holdig the position of Commissioner (CADWM & BWUE) and requested to merge National Water Mission (NWM) with Ministry of Jal Shakti Department of Water Resources, RD & GR as nominations are from the same ministry. The Council decided to merge NWM with Department of Water Resources, RD & GR, Ministry of Jal Shakti.
