**Resolution 1 (Item 2.3)**

The Committee decided to seek representation of alternate members from below organizations:

**Resolution 2 (Item 2.4)**

Chemco Industries Pvt. Ltd., Mumbai vide letter dt. 26-04-2024 have proposed to hold the next WG meeting in 2 weeks' time. The updated draft can be subsequently put up for the decision of wide circulation.

**Resolution 3 (Item 3)**

The Committee noted the documents for revision of pre 2000 standards which were yet to complete the wide circulation period. In case no comments are received in two weeks' time, the documents listed at Item 3 may be finalized in consultation with the Chairperson.

**Resolution 4 (Item 4)**

The Committee decided to adopt ISO/TS 23148: 2024 Compatibility of lubricants with synthetic male condoms. The draft to be widely circulated for a period of one month.

### **Resolution 6 (Item 7)**

The Committee decided to circulate IS 13450 (Part 2/Sec 2): 2019 /IEC 60601-2-2: 2017 *Medical Electrical Equipment Part 2 Particular Requirements for Basic Safety and Essential Performance Section 2 High frequency surgical equipment and high frequency surgical accessories* for further comments from members.

It was decided to explore the existing standards for Balloon Ablation and to check for the organizations wherever the product is still in use. It was proposed to form a new WG under MHD3 for this purpose.

The Committee approved the Indian delegation proposed at Item 9.2 of agenda. The Committee also decided to include the experts from HLL, Thiruvananthapuram in the Indian Delegation to ISO/TC 157 Meetings in September, 2024 at Australia.
