- 3. A question was raised as to a use case repository within the IEC. This is being finalized internally and will be circulated to the National Committees within the coming months. The process may take up to a years to resolve. Guide 125 will be the primary document. The document goes through commenting and approval.
- 4. WG1 will review the terms of reference with respect to digital transformation and alignment with SG12 moving forward.

Youichi responded that the navigation tool is independent though it will rely on other repositories and databases. Preferably those would be automatically integrated. It is suggested that the SMB issue guidance on how the IEC intends to support the tools.
- 4. IEC SEC recommends that a formal proposal be made to both SG12 and SMB in order to formalize activities.
- 5. The JP National Committee would seek support to implement the tool as well as seek feedback as to the perceived value of the tool.
