**Decision 2024-10 12:** The SyC SM plenary approves the circulation of a Q document, including the workplan, to decide whether to begin the review process of IEC 63306 parts 1 and 2.

**Decision 2024-10 13:** The SyC SM plenary agrees to ask the IEC SEC to remind the following P-members of their obligations; Austria, Israel, Italy, and Netherlands. Failure to meet these obligations will result in their membership being revised to O-membership.

#### Unanimity

**Decision 2024-10 14:** The SyC SM plenary shares the concern of TC 65 that the project ISO IEC 18975 represents a duplication of scope with the IEC 61406 series and agrees with the approach to create a joint working group with a focus on creating a single standard for publication. SyC SM also supports the proposal to set the project ISO IEC 18975 on hold until a resolution can be reached.
