MINUTES

ITEM 0 WELCOME

- 0.1** The Member Secretary welcomed all the members to the third meeting of LITD 37. After introduction of the members, the Member Secretary requested the Chairperson to kindly deliver his welcome address and initiate the proceedings.
- 0.2** Prof Prabhat Ranjan extended warm welcome to all the members present and requested all the members for their effective and constructive contribution in standardization activities of the committee. He emphasized on the importance of active participation of the members in the committee meetings and plenary meetings of ISO/IEC JTC 1/SC 43.
- 0.3** It was also informed to the members that India has proposed hosting of SC 43 Plenary and Working Group meetings next year along with the IEC GM, tentatively in September 2025.

ITEM 1 FORMAL CONFIRMATION OF THE MINUTES OF THE LAST MEETING

- 1.1** The committee formally confirmed the minutes of the last (3rd) meeting of Brain Computer Interface Sectional Committee, LITD 37, which was held on 28th March 2024 and were circulated vide email dated 7th May 2024 since no comments were received.

ITEM 2 SCOPE & COMPOSITION OF SECTIONAL COMMITTEE

- 2.1** The committee reviewed the scope and composition as per the information given in item 2.1 and 2.2 of the Agenda. It was decided to re-circulate the scope of the committee with members to revisit the scope, particularly, the part with respect to providing guidance to JTC1, IEC, ISO and other entities developing applications of BCI.
- 2.2** The committee also discussed regarding forming liaisons with other sectional committee that are working in standardization in areas that have impact and relation with the work going on in LITD 37.
- 2.3** The committee reviewed composition as given in ANNEX 2 of the Agenda and the co-option request given at 2.3 and decided to co-opt the following organizations:

- 2.4** The committee reviewed list of nominated experts in various Working Groups(WG) of JTC 1/SC 43 as given in ANNEX 3 of the Agenda and decided to register and de-register the following members as experts in respective WGs of JTC 1/SC 43:

 - ii. Nominate Dr. Nirmal Surya, IFNR as expert in WG2.
- 2.5** The committee noted the information given under item 2.5 of the Agenda. The committee and the chairman expressed appreciation towards all the wonderful work and extensive contribution in the standardization efforts at ISO/IEC level by the SC 43/WG 1 convener, Dr. Saurin Parikh, SC 43/WG 2 Convener, Dr. Arpan Banerjee and Project Editor for BCI Vocabulary standard, Prof Azizuddin Khan.
- i. WG 1 convener, Dr. Saurin Parikh, briefed the committee regarding the work undertaken in SC 43/WG 1 including projects such ISO/IEC CD 8663 BCI-Vocabulary, ISO/IEC WD 27572 BCI Reference Architecture.
 - ii. WG 2 Convener, Dr. Arpan Banerjee, also shared with the committee regarding the work undertaken in SC 43/WG 2 including projects such as ISO/IEC TR 27599 ED Use Cases.
- 2.6** The committee decided to formulate the following Working Groups corresponding to WGs of SC 43:

 - ii. WG 2 Applications
 - iii. WG 5 BCI data

- 5.2** The members who had participated in the last meeting of JTC 1/SC 43 shared their report of participation verbally during the meeting. The chair emphasized on the importance of physical participation and networking in these meetings.
