#### **ITEM 0 GENERAL**

#### 0.1 Welcome Address by DDG (Standardization-I)

Shri Rajeev Sharma, DDG (Standardization-I) welcomed all the esteemed members present. In welcoming the Chairman of ETDC and congratulating him on assuming this role, he expressed confidence in the leadership of Shri Rajput in guiding and steering the standardization activity in the Electrotechnology sector.

He highlighted that the standards development process is going online at ISO and IEC level with the development of 'smart standards' and deployment of Online Standards Development (OSD) platform, which will not only change the way in which we engage in the standardization process but also require us to be aware of the processes. He emphasized that internationally, standards are no longer being viewed as standalone documents but increasingly, they are being considered from the viewpoint of 'standards as a service'. It requires our national standardization community also to reorient its viewpoint towards standards.

He informed that addressing sustainability aspects in our standards is the need of the hour and informed that BIS is also considering to establish a dedicated technical department realted to Environment and Ecology to facilitate development of standards to address sustainability. To strengthen our foothold in the International Standardization activity, he encouraged the members to enhance their active participation in IEC, also by going through the draft standards and commenting on them.

While the 88<sup>th</sup> IEC General Meeting is taking place this year in Edinberg, UK, he informed that the 89<sup>th</sup> IEC General Meeting is scheduled to held in New Delhi during 2025. He requested all the members to actively participate in these events and encouraged them to share with and learn from the experts, the best in the respective technological domains.

He appreciated and placed on record the substantial contribution made by Shri V. S. Nandakumar, as earlier chairperson of ETDC, to the standardization activity in electro-technology sector.

#### 0.2 Opening Remarks by Chairman, Electrotechnical Division Council (ETDC)

Shri Ashok Kumar Rajput extended a warm welcome to all members present. He thanked BIS in appointing him as Chairman of ETDC. While praising BIS for being a very responsible organization, he informed that even national regulations on electrical safety derive confidence from Standards. He said that standards address quality and safety aspects in a uniform and neutral manner and encouraged the members to strengthen their participation in IEC through BIS.

He echoed the sentiments of DDG (Standardization-1) on the importance of addressing sustainability in our standards and highlighted the efforts the Government is making though specific missions like 'LiFE' to promote sustainable practices. He shared the vision of Government of India on Energy Transition and enhancing the share of green energy which include renewable energy, hydro electricity as well as Green Hydrogen.

He encouraged all the members of various sectional committee of ETDC to enhance the speed of standards development. While noting that BIS is going to host the IEC General Meeting in 2025 in India, he suggested that BIS may associate all the relevant organizations and Ministries/Department in the event for the benefit of all staeholders.

The meeting started with a brief introduction of all the participants.
