- API, Implementation of Digital Data Highway (API Setu)
- Requirements and implementation of Digital Voting & M-Voting – *Internship project has been allocated by BIS*
- Standardization of the data format in citizen-centric application & language in the websites
- The 2nd version of India Enterprise Architecture – *Draft currently under finalization by MeitY*
- Digital Governance Conformity Assessment Framework guidelines

4.2 OTHER POTENTIAL SUBJECTS UNDER CONSIDERATION BY THE COMMITTEE

During the last meeting the committee discussed the possibility of working in the following areas and requested the LITD-25 Chairperson to share the draft documents for review by the committee members. Based on the inputs received, a suitable decision may be taken in the next (7th meeting) of LITD-25:

- Platform conformity Assessment (also applicable on Digital Locker) – *Draft document shared by STQC is given in Annex-3.*
- Data Anonymization – Precisely which framework to be used – *Work already initiated in LITD 17*
- Data Centres Framework – Operational requirement (Not design)
- Zero Trust Architecture – *Committee may provide inputs*

- Generative AI and its role in Digital Governance (e-Governance) – *During the last meeting, Member Secretary informed that the LITD 30 is already working on Artificial Intelligence related projects.*
