CED 53/A2.24/RN-8	CED 53 decided to confirm the Minutes of the 23 rd Meeting.
CED 53/A2.24/RN-9	CED 53 noted the composition and decided to send letters to the non-participating members as reminder and based on their attendance in the next meeting, decision to retain or remove may be taken.
CED 53/A2.24/RN-10	CED 53 decided to form a Working Group for Item 3.1, 3.3 and 3.4 with following members: a. Sh A.K Jain, In personal capacity, b. Sh Jawahar I Rawtani, Everest Industries Limited, c. Sh S K Singh, CSIR-CBRI Roorkee, d. Member from EIL, e. Member from NCCBM. For Item 3.2, the Committee decided to form a Working Group with at least two manufacturers and two users. The Convenor may be decided in the next meeting.
CED 53/A2.24/RN-11	CED 53 discussed the Item 4.1 and decided to go through the letter received from M/s The Fiber Cements Products Manufacturers and Quality Control Orders as issued and in case any anomaly found in the dimensions as permitted in the ISSs, amendment may be issued.
CED 53/A2.24/RN-12	CED 53 decided to reconstitute the members of the Working Groups. It was decided to make Sh S K Singh, CSIR-CBRI Roorkee the Convenor of Working Group at sl 3 and 5. It was also decided to dissolve the Working group at sl 7 and 9. For remaining Working Groups, discussion will be held with members and decision on the Convenor and members will be taken in the next meeting. For Item 5.1, CED 53 decided to present the proposal indicating the differences in IS 458 for further discussion. For Item 5.2, CED 53 decided to highlight the comments/suggestion in the drafts as submitted and then further discussion may be held. For Item 5.3 and 5.4, CED 53 noted that they were repeated items and already covered in the Agenda. For Item 5.5, CED 53 decided to present the details of the comments again.
CED 53/A2.24/RN-13	CED 53 noted the progress of work and decided to first categorize all the standards among groups – Precast Products, Asbestos based products, Pre-stressed Products, AAC/ACC products. It was decided to form Working Groups for each classification and the revision/review of the ISSs will be taken up.
