3.1 Draft Indian Standard Smart Community Infrastructures — Review of Existing Activities Relevant to Metrics DOC NO. (25828) WC

Item 4 INTERNATIONAL ACTIVITIES AND HARMONIZATION

4.1 India is a 'P' (Participating) Member in ISO Technical Committee namely; 'ISO/TC/268 Sustainable Cities and Communities' and its Subcommittee 'ISO/TC/268/SC 1 Smart Community Infrastructures' and ISO TC 268/SC 2 'Sustainable cities and communities - Sustainable mobility and transportation'. List of ISO Standards published and under development under this committee and its two sub-committees.

India is a signatory to WTO Agreement on Technical Barriers to Trade (TBT) and has aligned its standards formulation procedures to the 'Code of good practices for preparation, adoption and application of standards'. One of the provisions of the code requires BIS to use international standards wherever they exist as a basis for standards being developed and wherever practicable to do so.

The Committee may **note** the above, the international standards published and the subjects under development in ISO TC 268 and its sub-committees for information and their effective utilization in the standardization work undertaken by the Committee.

It may be noted that, in every meeting of the Sectional Committee it has been requested to all the members to actively participate in the standardization work of ISO/TC 268 and its sub-committee and provide comments on the ballots circulated by BIS Secretariat. It is required for showing active participation of CED 59 as the National Mirror Committee at ISO level. In addition, as India is regularly voting on various draft International Standards,

it would be worthwhile to participate and contribute/influence International standardization in this area.
