ITEM 0: WELCOME ADDRESS

Opening remarks: Prof. Inder Gopal, Chairperson of the committee, in his opening remarks told that smart city mission has been extended till March 2025, for complete implementation of the project. Sh. Rahul Kapoor, has joined as the mission director of the smart city mission. Further he informed that NUDM is going to come up with City Operating Platform (COP), which will include the data exchange work, which we have been doing and IoT. Thus, it will support also OneM2M. The committee has already published a set of standards in certain areas and these standards are going to be very influential in smart cities. He further urged the members to contribute more actively towards the development of standards planned for the future.
