ITEM 7 COMMENTS ON PUBLISHED STANDARDS

7.1 a) IRGMA has put forth their suggestion to incorporate GOVT OF INDIA RULES Banned Chlorinated Gloves in the standard IS 15354 (Part 1): 2023 'Single Use Medical Examination Gloves Part 1 Gloves Made from Rubber Latex or Rubber Solution — Specification (*Second Revision*)'.

The concerns of IRGMA were noted. The Committee deliberated on this matter in detail and observed that GOVT OF INDIA Rules is the law of land and everyone has to follow the same.

The Committee also decided to recommend the standard to the panel MHD 12: P1 - Gloves for a detailed analysis and further deliberation.

b) The Committee decided to withdraw IS 4148:1989 'Surgical rubber gloves — Specification (*First Revision*)' being obsolete and unsafe usage as there is high risk of spread of nosocomial infections from re-use of Surgical Gloves.
