#### ITEM 5 SUBJECTS UNDER CONSIDERATION

# 5.1 Coastal Erosion Protection Using Gabions — Guidelines

**5.1.1** In the previous meeting, the Committee asked the member secretary to circulate the draft document submitted by Smt. Minimol Korulla on metal gabions to all members and requested them to provide their feedback within 10 days. In response, Dr. Sundar reviewed the draft and raised some queries that needed to be addressed in the draft. Maccaferri has provided responses to Dr. Sundar's queries, and the draft document is attached with the agenda for the Committee's review.

**5.1.2** The Committee also requested Garware Technical Fibers Ltd to take the lead in providing inputs on polymer rope gabions within one month, which could be discussed at the working group level. The Committee further requested the working group to finalize the document within two months and circulate it among the members as a P-draft. Reminders for inputs were sent vide BIS emails on 17 May 2024, 12 June 2024, and 26 July 2024. It has been informed that the document is still under preparation and has not yet been submitted.
