# 19th MEETING OF 'FIBRE OPTICS, FIBRES, CABLES AND DEVICES' SECTIONAL COMMITTEE, LITD 11 (Hybrid)

- 1. The committee formally confirmed the minutes of the last 18th meeting of LITD 11 sectional committee held on 21 November 2023.
- 2. The committee **decided** to co-opt IIT Kanpur in the committee, with a request that Prof. Anantha Ramakrishna may be nominated as one of the representatives from IIT Kanpur.
- 3. The committee also **decided** to seek revised nominations in the committee, from TEC. Also, the committee requested CEAMA to review its nominations in the committee since currently. The committee **requested** the Member Secretary to write letter to following organizations for reviewing their nominations:
  - Telecommunication Engineering Center
  - ➤ Consumer Electronics and Appliances Manufacturers Association
- 4. The committee requested Panel 1 to initiate the revision of IS 17046: 2018 "Fibre Optic Cable for Cable TV Application' taking into latest technology and raw materials into consideration and wider stakeholders consultations including Cable TV industry members.
- 5. It was **decided** that withdrawal of IS 16939: 2018 'Optical Fibre Cables For Inside Premises FTTX Application/may be deferred till comments of other members of LITD 11 and from industry are also received.
- 6. Further, it was **decided** to circulate the IS 16939: 2018 'Optical Fibre Cables For Inside Premises FTTX with committee members and panel members/industrial experts for their inputs and comments.
- 7. The committee requested Panel 1 to take this also in consideration during the preparation of the revised draft of IS 17046 "Fibre Optic Cable for Cable TV Application".

8. The committee recommended reaffirming the due for review standards for an additional three-year period from the scheduled review date.
