Dear Sir/Madam,

Thank you to the participants of yesterday's meeting (23 Oct 2024). Following are the major decisions of the meeting:

1. The committee reviewed the composition and requested all the committee members for their active participation.
2. LITD 7/Panel 1 was requested to examine the relevant groups and standards of ISO/TC 43. It was decided that decision regarding P-membership will be considered subsequently based on the recommendations of the LITD 7/Panel 1 and interest of stakeholders for active participation. ALPS had already volunteered for participation, other members were requested to volunteer as well as to suggest related stakeholders.
3. It was decided to include all co-option requests (including ECIL) as invitee except Mr. Durgesh Vishwakarma. Based on their contributions, the decision for cooption will be taken in sub-subsequent meetings. It was also decided that participation should be through their organizations.
4. It was decided to finalize the documents LITD/07/24465, LITD/07/24444 and LITD/07/24432 for publication as Indian Standard. It was decided that decision w.r.t LITD/07/24644 and LITD/07/24643 will be taken subsequently.
5. It was decided to issue documents LITD/07/23762, LITD/07/23763 & LITD/07/23764 in wide circulation for a period of 2 months.
5. It was decided to issue LITD/07/26689 (Revision of IS 18112:2022) in wide circulation for a period of 1 month. All were specifically requested to inform if any specific change is required or any guidance needs to

be included related to the column 5 'Compliance criteria and Test Method(s)'. LITD 7/Panel 5 may plan meeting before completion of wide circulation period to discuss any such change, if required.

7. It was decided to revise IS 11889 :2018 & IS 7194: 2018 to align with the corresponding ISO standard.
3. The committee reviewed the standards to be reviewed during April 2024-March 2025 and agreed to the recommendation as mentioned in Annex-3 of agenda.
2. The committee reviewed the standards as mentioned in annex-4 and decisions are as follows:
  - a. It was decided to recommend withdrawal of IS 10662 : 1992 'Receivers for colour television broadcast transmissions specification', IS 11453 : 1985 CCIR SYSTEM Bs Characteristics of systems for monochrome and colour television, IS 11975 : 1987 Methods of measurements for multi - Channel television tuners, IS 12997 : Part 1 : 1989 Television signal booster - Specification Part 1 wide band VHF range.
  - b. IS 11728 : 1986 (Identical to ISO 7736-1984) 'Code for installation space including connections for car radio for front installation' was recommended for transfer to Transport Engineering Department(TED).
  - c. It was also decided to again request for inputs w.r.t other standards mentioned in Annex-4.
10. LITD 7/ Panel 3 was requested to regularly plan meetings to review documents of IEC TC 100 and TC 108 to finalize India's view related to these documents.
11. LITD 7/Panel 1 was requested to plan meetings to review documents of IEC TC 29 to finalize India's view related to these documents.
12. LITD 7/Panel 2 was requested to plan meeting at the earliest and to suggest further course of action related to the proposal 'CODE OF PRACTICE FOR INSTALLATION OF DTH (DIRECT TO HOME) AND CABLE TV'
13. LITD 7/Panel 4 was requested to suggest timeline and further course of action regarding 'Broadcast loudness proposal'
14. The committee approved the virtual participation of Mr. Kshitij Bathla in IEC TC 100 meetings (18<sup>th</sup> November 2024 to 22<sup>nd</sup> November 2024).
15. The committee agreed to submit inputs as mentioned in Annex-5.
16. It was decided to again take up for all other items where inputs are awaited.
