ITEM 0 GENERAL

- **0.1** The Member Secretary welcomed all the members to the tenth meeting of LITD 29. He informed the members about the mandate given to this committee also informed about the work done by the committee during the last one year. He stressed on the need for having necessary Blockchain standards and incorporating India specific requirements in the ISO standards on Blockchain.
- **0.2** Sh J A Chowdary welcomed and thanked all the members to attend the meeting amidst their busy schedule. He appreciated the work done by various members and encouraged LITD 29 Panels to have their separate meetings. He encouraged members to volunteer towards various leadership projects emerging in Blockchain standards but also give due consideration to the time commitments before taking such roles. He informed about the status of Digital Payment systems using Blockchain and National Blockchain Technologies Framework (NBTF). He then requested Member Secretary to carry on with the Agenda items.

ITEM 1 FORMAL CONFIRMATION OF THE MINUTES OF THE LAST MEETING

1.1 There being no comments from the members on the minutes circulated on 05 July 2023, the Committee formally confirmed the minutes of its last meeting held on 21 June 2023 virtually.

ITEM 2 COMPOSITION OF LITD 29

The committee also decided that any member/organization not contributing in the committee work for more than 1 year will be recommended for removal by the committee.

ITEM 3 PROGRAM OF WORK

3.1 The committee noted the present position of work of LITD 29 as given in Annex 3 of the agenda.

ITEM 4 ACTIVITIES OF THE PANELS UNDER LITD 29

4.1 At present, LITD 29 has 6 panels under it which follow the work of corresponding TC 307 Working Groups. The panels were expected to have their separate meetings and to provide their inputs on the various projects to the corresponding TC 307 WGs.

4.1.1 LITD 29/Panel 1 Foundations

In absence of Panel 1 Convener, the Member Secretary briefed the committee about the status of various projects under TC 307/WG 1. It was informed by the member secretary that the ISO 22739 Vocabulary has been revised in 2024 and TC 307/WG 1 has been disbanded.

The committee decided to revise IS 22739 based on revised ISO 22739. The committee decided to circulate ISO 22739 in wide circulation for a period of 2 months for comments. The comments received will be discussed by Panel 1.

Further, the committee decided to disband Panel 1. The committee thanked Panel members for their contribution.

4.1.2 LITD 29/Panel 2 Security, Privacy and Identity

In absence of Panel 2 Convener, the Member Secretary briefed the committee about the status of various projects under TC 307/JWG 4. The member secretary informed about the following drafts and standards under discussion in JWG 4 :

- a) ISO/NP 23042 Reference architecture for DLT-based decentralized identity systems
- b) ISO/WD 25126 Information security controls based on ISO/IEC 27002 for distributed ledger services
- c) ISO/WD 24946 Requirements and guidance for improving, preserving, and assessing the privacy capability of DLT systems.
- d) ISO/WD 24876 Privacy protection when involving trust anchors in DLT-based identity management
- e) ISO/PWI 24875 Secure smart contracts

The committee requested Panel 2 Convener to conduct Panel 2 meetings and decides India's position on the above drafts.

Further, the committee decided to adopt following ISO/TC 307 standards as Indian Standards.

ISO TR 23644 : 2023 Blockchain and distributed ledger technologies (DLTs) — Overview of trust anchors for DLT-based identity management

The above draft Indian Standards will be circulated in Wide Circulation for a period of 2 months for comments. The comments received will be discussed by Panel 2.

b) IOT device lifecycle management through Blockchain

ISO 6039 : 2023 Identifiers of subjects and objects for the design of blockchain systems

The above draft Indian Standards will be circulated in Wide Circulation for a period of 2 months for comments. The comments received will be discussed by Panel 6.
