As revision of IS 12823 and IS 3097 already taken while amalgamating in revision of IS 3087, the Committee finalized (skipping again wide-circulation, as same have already been wide-circulated in amalgamating with WC draft of IS 3087) the draft standards for revision of IS 12823 & IS 3097 presented (separated from WC draft for revision of IS 3087) and discussed during the Meeting for ADOPTION and PUBLICATION along-with modifications discussed and decided during the Committee Meeting.</p>
