#### 3.4 Standards National Action Plan (2022 - 27)

In the last meeting, the Committee decided that groundwater flow monitoring has been replaced with groundwater flow modelling.

BIS has taken a proactive and progressive approach for formulation of Indian Standards by developing a Standards National Action Plan (SNAP) as part of Indian National Strategy for Standardization (INSS). Under this plan, BIS has identified key standardization areas for development of new standards by extensive consultation with various stakeholders.

Such subject area identified under the sector 'Water Resources', which could be under the purview of WRD 03 are:

- a) Aquifer Storage and Recovery Techniques
- b) Guidelines for aquifer mapping
- c) Impact assessment techniques for artificial recharge structures
- d) Guidelines for surface runoff harvesting using small structures
- e) Groundwater harvesting using unconventional methods
- f) Groundwater flow modelling
