Subject: Option 2 (erstwhile Simplified Procedure) for GoL - Mandatory Expansion - reg.

- 1) This has reference to the subject mentioned above.
- 2) For considering GoL as per Scheme I of the Conformity Assessment (Regulations) 2018, manufacturers may utilize any one of the following available procedures:
 - (i) Option 1 (For Domestic as well as Foreign Manufacturer)
 - (a) Based on TR (from TPTL) of the sample drawn by BIS (Available for all products except for the products permitted under FT)
 - (b) Based on FT (Available for products permitted under FT)
 - (ii) Option 2 (For Domestic Manufacturer only)
 - (a) Based on TR (from TPTL) submitted by manufacturer
 - (b) Available for all products except for the products permitted under FT and products such as cylinders, valves, regulators, cement, etc., where a joint inspection or approval is required from another statutory authority; and Packaged Drinking Water (PDW) and Packaged Natural Mineral Water (PNMW)
- 3) At present the manufacturers have the choice to apply as per Option 1 and Option 2. Through various reform measures instituted to improve the conformity assessment system of BIS, it has been possible for BIS to grant licences under Option 2 within the time norms of 30 days. In spite of the best efforts taken by BIS to reduce the compliance burden, the testing charge of review sample which is to be borne by the manufacturer as per Option 2 was an impediment to more manufacturers voluntarily opting for Option 2.
- 4) Now, as per the proposed amendment in the BIS (Conformity Regulations), 2018, the testing charges of the review sample shall not be borne by the manufacturer (This will come into effect after notification of amendment in the Regulations by the Central Government). Considering this, it has now been decided to bring more products under the ambit of Option 2, making it mandatory for the manufacturers to apply for GoL as per Option 2 procedure only. This means that there will not be any choice for the manufacturers to select Option 1 or Option 2 for those products

which are mandatorily classified under Option 2. The provisions are being enabled in manakonline to make such restrictions.

- 5) All existing applications already recorded in manakonline and under various stages of processing shall be processed as per the opted procedure. All new applications for the products mandatorily listed under Option 2 shall be processed as per Option 2 only upon its enabling in manakonline.
- 6) The consolidated revised guideline for GoL incorporating the above provisions is being issued separately.
- 7) This issues with the approval of DG, BIS.
