This has reference to the subject mentioned above.

- 2) In this regard, BOs may kindly note the following:
 - As per Regulation 6(11) of the BIS (Conformity Assessment) Regulations, 2018, the licensee shall provide the list of consignees, distributors, dealers or retailers to whom goods or articles with Standard Mark is supplied.
 - ii) The necessary enablement of IT provisions in e-BIS/Manakonline portal have been undertaken by ITS department. The information about the same may also be disseminated to licensee under your jurisdiction for necessary compliance.
 - iii) In this regard, licensees would now be required to submit month-wise consignee details (with complete address and quantity supplied) on ManakOnline portal on quarterly basis. To start with, the month-wise consignee details for the period from January 2021 to March 2021 shall be filled in the e-BIS/Manakonline portal by 30 April 2021. Subsequently, the month-wise consignee details shall be filled in the online portal by 10th. For example, the details for the period from April 2021 to June 2021 needs to be filled by 10 July 2021 and so on.
- 3) ROs/BOs may also kindly note that in the event of failure to comply with conditions of licence, licences are liable to be considered for cancellation as per Regulation 11(1)(a) of BIS (Conformity Assessment) Regulations, 2018, as per the prevailing guidelines.
- 4) This issues with the approval of the DDG (Certification).
