This has reference to the document of even number dated 12 April 2021 on the subject cited above.

- 2) In this regard, kind attention is invited to extract from clause 1 and clause 5(1)(i)(c) of the aforesaid document stated below:
 - "1. guidelines for monitoring operation of product certification licences and checking conformance of product available in the market as per applicable Standard(s)......"
 - "5(1)(i)(c) The licensee shall upload month-wise consignee details (with complete address and quantity supplied) on the online portal which are to be updated on quarterly basis. The ROs/BOs shall check the adequacy and completeness of such information filled by the licensee on the online portal."
- 3) As per the discussion held on this matter and takeaway point of the review meeting with ROs/BOs in April 2021, issues were expressed in the submission of consignee details by the licensee especially when the number of such consignee is too large.
- 4) In this regard, BOs shall endeavour that licensee adheres to submission of information as per clause 5(1)(i)(c) of guidelines on subject matter w.r.t. consignee details (with complete address and quantity supplied).
- 5) In case any issues are being expressed by the licensee for a particular licence, then based on assessment about sufficiency of consignee data for effective market surveillance operation, Head (BO) may by recording reasons authorise relaxation in such particular cases.
- 6) However, the licensee shall be advised for appropriate regular updation of information like deletion of obsolete consignee and addition of new consignee etc.
- 7) This issues with the approval of DG, BIS.
