## ITEM 0 WELCOME

- 0.1** At the outset, the Member Secretary welcomed the Chairman and members. He further thanked them for attending the tenth meeting of E-Learning sectional Committee, LITD 19. He then requested Chairman to give his opening remarks.

Dr H R Mohan suggested that a survey may be done to gather inputs from various institutes/universities on the present status of E-Learning, ranging from technology used to practical implementation. Committee members welcomed this suggestion. Member secretary clarified to the members that BIS works in standards formulation activity and thus, may not be able to contribute in the creation of a portal. CDAC officials **volunteered** to check with their competent authority if CDAC can arrange for this provision. CDAC was **requested** to provide an update regarding this. In the absence of a portal for the same, we may gather inputs from emails (or) Google forms. Chair, LITD 19 added that a presentation (study report) on this topic was also presented by Smt. Rama Devi during a webinar.
