#### Item 0 GENERAL

#### **0.1 WELCOME AND OPENING REMARKS BY THE CHAIRMAN**

**2.1** Committee noted the information given in the agenda. The committee decided to withdraw the membership of Indian Electrical and Electronics Manufacturers Association, New Delhi, due to their consistent absence from sectional committee meetings, and lack of participation.

#### 2.2 Sector Wise Classification of ETD 32 Sectional Committee

Committee noted the information given in the agenda. Details of experts for standardization work in the corresponding sector/sub-sector, given by committee members, is given at **Annex 2**.

**2.3** The committee considered and deliberated upon the co-option requests received. Co-option request of MANIT, Bhopal was accepted by the committee. Co-option requests of V-Guard Industries Ltd. and Franke Faber India Pvt Ltd were rejected by the committee, citing already substantial representation of industry in the committee composition. It was decided that Shri Mukherjee may submit a draft on the lines of IEC TS 62950:2017 (Household and similar electrical appliances - Specifying smart capabilities of appliances and devices) for ETD 32 to work upon and take forward.
