Item 3 PRESENT SCOPE AND TECHNICAL WORK PROGRAMME OF THE COMMITTEE

3.1 Title: Interconnection and Information exchange among IT equipment and systems

Scope: Standardization in the field of:

- a) Computer communication networks and interfaces to these computer Communication networks including microprocessor systems, interfaces, Protocols and associated interconnecting media for IT equipment and networks.
- b) Home and building electronic systems in residential and commercial environments to support interworking devices (IoT-related) and applications such as energy management, environmental control, lighting, and security.
- c) Telecommunications dealing with Information exchange between IT/ICT systems encompassing protocols and services of network layers

Liaison ISO/IEC/JTC 1 SUBCOMMITTEES:

- a. ISO/IEC/JTC1/SC 6 Telecommunications and information exchange between Systems P Member
- b. ISO/IEC/JTC1/SC 25 Interconnection of information technology equipment P Member

- **5.2** India is participating member in ISO/IEC/JTC 1/SC 6, ISO/IEC/JTC 1/SC 25. As P member, India has obligation to vote and comment on the documents emanating from ISO/IEC/JTC 1/SC 6, ISO/IEC/JTC 1/SC 25 .Participating Countries can also nominate their experts on the working Group to participate in international standardization activities.
- **5.2.1** SC 6 has published 384 standards so far. The standards published by SC 6 is given at **Annex-5**. The standards under development by SC 6 is given at **Annex-6**. Around 32 standards are presently under development stage.
- **5.2.2** SC 25 has published 222 standards so far. The standards published by SC 25 is given at **Annex-7**. The standards under development by SC 25 is given at **Annex-8**. At present only one standard is under development.
