Item 3 P-DRAFT FOR APPROVAL FOR WIDE CIRCULATION

The Panel for drafting standards on distribution network and vocabulary SSD14/P3 has conducted five panel meetings and finalised the draft document on 'Guideline for the Management of Assets of Drinking Water Supply System' attached as Annex 2, in the fifth panel meeting held on 04 April 2022. As recommended by the Panel, the Sectional Committee decided to circulate the draft document as P-draft. After the approval of the Chairperson, the Member Secretary circulated the draft document as P-draft to all the member of the Sectional Committee SSD14 for 15 days for comments. The last date for comments on P-draft was 06 May 2022. No comment on P-draft is received until now.

Item 4 DRAFTS UNDER CONSIDERATION

Item 6 TRANSFER OF SUBJECT FROM CHDC TO SSDC

6.1 SSD 14 requested CHD 32 vide email dated 19/01/2022 to transfer Indian standards related to services and published earlier under CHD 32 along with liaison

of ISO/TC 224. These International standards pertaining to ISO/TC 224 were published as Indian standards by CHD 32 after adoption. While deciding on the request of SSD 14, it was also felt by CHDC and CHD 32 that the scope of SSD 14 is more relevant to deal with activities of ISO/TC 224 and few standards adopted as Indian standards until now covers services aspects. Finally, the Division Council of Chemical Department (CHDC) has decided to transfer the following Indian Standards published under CHD 32 earlier to SSD-14 for further action is given below:

6.2 Presently, the work of liaison with ISO/TC 224 is being done by Environment Protection Sectional Committee, CHD 32.

The scope of ISO/TC 224 is given below:

"Standardization of the management concepts for service activities and processes relating to drinking water supply, wastewater and stormwater systems.

This structure includes activities necessary to fulfil the objectives of water supply, wastewater and stormwater systems. Water supply for purposes other than drinking water can be included in this management concept structure.

Excluded:

- a) Normative target or threshold values for service quality criteria;
- b) Normative limits of acceptability for drinking water quality or for wastewater and stormwater discharges to the environment;
- c) Product specifications for chemical and biological additives for water and wastewater treatment;
- d) Standardization in sludge recovery, recycling, treatment and disposal;
- e) Standardization in water reuse;
- f) Methods for the measurement of water quality."

On request of SSD 14, CHDC has approved the recommendation of CHD 32 to transfer the liaison responsibility of ISO/TC 224 to SSD 14 under Service Sector Division Council (SSDC). Henceforth, Drinking Water Supply, Wastewater and Storm Water System Services Sectional Committee, SSD 14 would liaison with ISO/TC 224 for all standardization activities under it.
