Subject: Certification of Safety of Toys – Regarding

1. This has reference to the above.
2. During review of status of pending applications by DG, BIS on 28 Sep 2020, it was observed that in several applications for certification of safety of toys, the applicants have not submitted declaration indicating the complete details of their product varieties as per the Appendix-II of the Product Manual.
3. The requirements/tests that are applicable for toys vary depending upon the varieties of toys for which licence is being applied. Hence, if applicants do not submit this declaration, BIS will not be able to assess whether the required test equipment/facilities are available with the applicant or not.
4. In light of the same, Branch Offices are advised to inform all applicants to submit the above declaration (the document to be uploaded under undertaking/declaration). Further, whenever applications for safety of toys are received, it should be checked that applicant has submitted the declaration as per Appendix-II of the Product Manual.
5. If it is observed that the applicant has not submitted the declaration or the same is not in order, the BO shall, after conveying the same to the applicant through Manakonline, also hold a VC/meeting with the applicant to ensure that they have understood what has to be submitted and if required, guide them in framing the declaration appropriately. (Photos/details of their products may be obtained through email etc. to understand the varieties being applied for).
6. However, as already mentioned in the BIS/DGO(3)/2020 dated 04 Aug 2020, factory inspection shall not be deferred for want of the reply of the applicant to be furnished. They should, instead, be asked to be ready with the information/clarifications/documents on the day of factory inspection itself. The complete technical verification of the documents shall be carried out during the factory visit.

7. All BO Heads are requested to ensure implementation of the above instructions and accord high priority to applications for safety of toys.
8. All BOs are also requested to create awareness among existing and new applicants regarding the modalities of BIS certification for safety of toys through regular industry interactions through VC.
