**Subject: Additional Guidelines for Implementation of revised IS 1848 (Part 1): 2018 and revised IS 1848 (Part 2):2018**

1. This has reference to the above and guidelines issued by CMD-2 vide circular no. CMD-2/16:1848 (parts 1 & 2) dated 07 01 2019 for implementation of revised IS 1848 (Part 1): 2018 and revised IS 1848 (Part 2):2018.
2. Separate Schemes of Inspection and Testing (SITs) for revised IS 1848 (Part 1): 2018 and revised IS 1848 (Part 2):2018 have been circulated on 25.02.2019.
3. The following additional guidelines have been approved by the Competent Authority for implementation in this respect:
  - i) Separate licence shall be granted for products as per the relevant part i.e. IS 1848 (Part 1): 2018 and IS 1848 (Part 2):2018.
  - ii) If the existing licence granted as per IS 1848:2007 covered only the varieties now covered only under IS 1848 (Part 1): 2018 or only under IS 1848 (Part 2):2018, the licence shall be converted to the relevant part as applicable.
  - iii) If the existing licence was granted wherein varieties as per IS 1848 (Part 1): 2018 and IS 1848 (Part 2):2018 are included in a single licence, it shall be split into different licences as per the relevant part as applicable. Existing licence number shall be retained with one of the licences and new licence number shall be allotted to the other.
  - iv) The following marking fee shall be applicable for the separate licences granted/operated as per IS 1848 (Part 1): 2018 and IS 1848 (Part 2):2018:
    - a. At present, the rate of marking fee shall remain same as per existing rate applicable for IS 1848 as given below

IS 1848	1 Tonne	60,000	48,000	8.6	All

- b. In case of one firm holds licences as per both the parts, Renewal application fee, licence fee and marking fee as applicable for each licence shall be charged separately
4. The above guidelines come into force with immediate effect
