It was also confirmed that the said location is a dispatch point for the online platform (maxbhi.com). Also, packing materials with branding of online platform was also observed during the visit.

		As per CI.7.10.3 of Guidelines for Enforcement Activity, Ref - CMED/GEN/5 dated 26 May 2023, it is recommended that legal prosecution for the violation, action for violation of Section 17(3) may be initiated against M/s Elcotek India Pvt. Ltd.
