P-20772 in which a discreet investigation carried out on 27-11-2024 revealed possible misuse of standard mark at M/s Amar Enterprises, Plot no. 170, KHasra no. 513/4, Laxmi Garden, Drouti Khurd, Loni Ghaziabad, Uttar Pradesh 201102. During the discreet investigation, it was observed that helmets were being manufactured at the said premises. Hence, an enforcement
		raid was planned on 03 Dec 2024. During the enforcement raid, it was observed the accused entities as listed at SI No. 16 above indulged in manufacturing of helmets without licence at Plot no. 170, Khasra no. 513/4, Laxmi Garden, Drouti Khurd, Loni Ghaziabad, Uttar Pradesh 201102, hence violating the Helmet for riders of Two Wheeler Motor Vehicles (Quality Control) Order, 2020 (S.O. No. 4252 (E) 26/11/2020) and misusing the Standard Mark of BIS under Section 17(1)(a) & 17(3) of BIS Act, 2016 During the search and seizure operation Approx 549 Helmets Marked with ISI mark and expired CM/L-8700023812, Brand PK=2 and approximately 272 Helmets without having any ISI mark were sealed and left under superdari. 8 pcs of the Helmets were sealed as
