### **Subject: Guidelines for implementation of Amendment No. 4 to IS 14543 : 2016, Packaged Drinking Water (other than Natural Mineral Water)**

1. Amendment No. 4 to IS 14543 : 2016 has been published. The last date for implementation of the amendment is **21 Feb 2020**.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment **within a week of issuance of these guidelines**.
3. The significant changes in the amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

<b>Clause no.</b>	<b>Change</b>
Clause 7.1 a)	Name of the product in Capital letters (that is, PACKAGED DRINKING WATER)
Clause 7.1 g)	To mention the following in capital letters BEST BEFORE.....(DATE/MONTH/YEAR); OR BEST BEFORE.....DAYS OR MONTHS FROM THE DATE OF PACKAGING/MANUFACTURE(in capital letters);
Page 3, Table 2, Sl. no.(xviii), col 2	Substitute 'Residual free chlorine, mg/l, Max' for 'Residual free chloride, mg/l, Max'.
Clause 8	Delete (Marking on water not meant for human consumption)

4. Consequent upon issuance of the amendment, existing SIT has been revised as Doc: SIT/ 14543/3 Jan 2020 which is being circulated separately.
5. All ROs/BOs are requested to ensure the implementation of the above guidelines by **21 Feb 2020**. BOs shall ensure that no Licences are under operation as per IS 14543 : 2016 without the amendment after **21 Feb 2020**.
6. The above guidelines come into force with immediate effect.
